Leech Lake Reservation History

The 1787 Northwest Ordinance

When European settlers first began to occupy this land, the American Indian tribes were recognized as sovereign nations and the government related to the tribes under the guidelines of international law. In 1787 the United States Government formerly recognized Indians with the passage of the Northwest Ordinance.

Article One, Section Eight of the United States Constitution

In 1789, congress passed Article 1, Section 8 of the U.S. Constitution. The article gave congress the power to regulate commerce with foreign nations, between the States and with the Indian Tribes. This article laid the foundation of the law from which more than two hundred (200) years of federal legislation and programs dealing with Indian tribes would derive.

Treaties

During the years of 1805 – 1889, the United States government signed a number of treaties with the native tribes. Treaties are legal binding agreements between two separate sovereign nations. All treaties made by the United States government with another nation must be ratified by the U.S. Senate. The U.S. Constitution in Article VI, Section 2 reads:

"All treaties made, or shall be made, under the

authority of the United States shall be the supreme law of the land and the judges in every state shall be bound thereby, anything in the constitution of laws of any state to the contrary notwithstanding."

These Treaties have the same legal dignity as any other international agreement.

Out of these treaties, vast amounts of land were ceded or given to the United States, reserving certain areas of land for the exclusive occupancy and use of the tribes.

The Three Lakes Area

When the first settlers arrived in this area, the Ojibwe had been living throughout northern Minnesota. The Pillager and the Mississippi bands had homes and villages on or near Cass Lake, Lake Winnibigoshish, and Leech Lake.

The area was covered with dense forests of pine, poplar, oak, cedar, maple, birch and spruce.

Treaties were negotiated to acquire a vast majority of this land in exchange for cash, goods and the setting aside of land for reservations that would forever be home of the Ojibwe.

Because of the existing treaties loggers could not get their hands on the magnificent White



Leech Lake Reservation has twelve communities in three districts.

Pine and Red Pine that has stood on Indian land for hundreds of years. That changed with the passage of the Nelson Act in 1889.

In 1896 and 1898 the towns of Walker and Cass Lake were established. Logging camps and saw and planning mills sprang up. Lumbering was the mainstay for decades. Farming and dairying developed later on the cut-over lands.

Nelson Act 1889

Congress passes the Dawes Act in 1887, which, combined with the Nelson Act two years later, allots 80 acres of non pine land, within the boundaries of the reservation, to each tribal family. The remainder of the non-allotted Indian lands were then opened up and sold or granted to timber companies, railroads and settlers. With the passage of the Nelson Act, loggers were able to move onto the land, and within a couple of years clear cutting was in full progress.

It should be noted, that with the passage of the Nelson Act, the state of Minnesota now claimed that tribal members were now subject to state hunting and fishing laws. No longer could tribal members hunt, fish, or gather on the Leech Lake Reservation as promised by the numerous treaties they had previously negotiated.

Another unforeseen problem was, allotments were to be held in trust for twenty five (25) years, upon which, Indians were then given a fee patent. As a result, most Indians lost their allotments through tax forfeitures, sales and/or fraud.

The Steenerson Act of 1904

The logging industry soon realized a huge profit could be gained if they could get access to the timber and land on the allotments being held in trust by the federal government. Thus began the lobbying of state legislators to enact laws allowing loggers access to timber on tribal allotments. The first such law was the Steenerson Act of 1904. This allowed the Department of the Interior to issue an additional 80 acres of land to tribal members they deemed "worthy". Attached to this Act was a rider called the Clapp Act. One day after the Steenerson Act was introduced, the Clapp Rider passed almost unnoticed. This Rider authorized tribal members to sell valuable timber resources from their allotments.

The Burke Act of 1906

The Burke Act gave the Secretary of the Interior authority to issue fee patents to tribal members if he deemed them "competent and capable".

However, in many cases Indians who were deemed competent often were not informed that they were deemed competent, nor were they informed that their land was now a fee patent as opposed to trust land. As a result, after a period of unpaid taxes, the land was sold without the owners consent to pay past taxes. This process was known as the "forced fee patent process."

A second Clapp Act in 1906 made a general proclamation only "mixed blood" tribal members were competent enough to make decisions about land sales for themselves.

Creation of the Chippewa National Forest

In 1908 concern over runaway logging prompt-

ed the Federation of Women's Clubs located in Minneapolis to establish a state forest on the Leech Lake Reservation to protect the remaining red and white pine from total destruction by the logging industry. In 1908 the Minnesota National Forest was established comprised of 225,000 acres. In 1928 the name was changed to the Chippewa National Forest.

Note, the establishment of this forest did absolutely nothing to curb the wide spread destruction of the majestic pine from the logging industry as intended. Over 95% of the white and red pine that was still standing when the Chippewa National Forest was established has been cut.

Meriam Report

In the mid 1920's the U.S. government commissioned a study of the American Indians. This report documented the deplorable conditions of Indian people across the United States, the devastation of the Nelson Act, and the failure of the Bureau of Indian Affairs to do anything about it.

In response, legislation was enacted called the Indian Reorganization Act of 1934. The Indian Reorganization Act put a stop to the sale of allotments, authorized tribes to establish their own governments, and restored all surplus lands (the Restoration Act) to the tribes that land not been sold under the Nelson Act.

Indian Reorganization Act of 1934

Under the Reorganization Act the federal government decided that the six (6) Ojibwe bands in Minnesota (not including Red Lake) would be recognized as the Minnesota Chippewa Tribe (MCT) and all lands that were restored on Leech Lake were in the name of the Minnesota Chippewa Tribe. The MCT adopt a constitution in 1937.

The 1964 Constitution vested political power in the Reservation Business Committees (RBCs) made up of a chairman, secretary treasurer, and one to three district representatives. In practice it became a five-member governing body on all six reservations.

The chairman and secretary-treasurer of each reservation are automatically seated on the 12-member Tribal Executive Committee (TEC).

Hunting, Fishing, and Wild Rice Rights

The Tribal Executive Committee voted unanimously in October 1968 to support Leech Lake's attempt to reclaim jurisdiction over its territory "with respect to hunting, trapping, fishing and wild ricing and the control, licensing and regulation thereof within the boundaries of the Leech Lake Reservation." As the TEC noted, Public Law 280 should have preserved tribal treaty rights, but the state simply refused to acknowledge them. In 1971 a federal judge ruled that the Nelson Act did NOT, as the state had argued, dissolve the Leech Lake reservation and that tribal members therefore retained hunting and fishing rights within its boundaries.

In the first major hunting, fishing, and wild rice rights cases in Minnesota, the Tribe confirmed that it had the right to control these activities on the reservation. The State pays the Tribe for its restraint in using the reservation's resources. In addition, the State conservation officers are deputized by the Tribe to enforce tribal natural resource codes.

Game and Fish Regulations

Members of a band may hunt and fish on any reservation under regulations provided by the band or tribe that have authority over the reservation. This applies to both trust and nontrust land within the boundaries of the reservation.

State jurisdiction on hunting and fishing laws over nonmembers is maintained for all reservations of the state. The reservation areas are considered "open" because the reservation trust lands are interspersed with nontrust lands. On "open" reservations nonmembers are subject to state jurisdiction. This question of nonmembers was litigated in federal court and affirmed.

Reservation Treaties

A series of treaties, also known as "reservation trea-

ties" were signed between the United States and the Indian tribes. Along with the treaties many promises were made. The promises included:

- Protection for the tribes from attacks
- Legal assistance
- Health care
- Education
- · Financial assistance
- Sovereignty
- · Religious freedom
- Confirmation and protection of certain rights
- Self-government
- Jurisdiction over their own lands
- Fishing and hunting rights

These promises were made in return for the tribes giving up their livelihood and traditional homelands. These promises were and still are legally binding upon the United States Article VI of the U.S. Constitution.

The Ojibwe living around Leech Lake signed treaties with the United States Government, and by doing so, the Leech Lake Reservation was created. In 1858, the state of Minnesota was admitted to the Union.

It is important to note the United States Government has been dealing with the Leech Lake Reservation on a government-to-government basis longer than Minnesota has been a state.

Land

The Leech Lake Tribe holds the smallest percentage of its reservation of any of the state's tribes. County, state, and federal governments owned well over half of the original land. Of the 864,158 original acres, nearly 300,000 acres are surface area of the three big lakes. The National Chippewa Forest has the largest portion of the land. Seventy-five percent of the National Forest is within the reservation. This leaves less than 5% of land owned by the Band.

The Minnesota Chippewa Tribe

The Minnesota Chippewa Tribe, comprised of the Bois Forte, Fond du Lac, Grand Portage, Leech Lake, Mille Lacs, and White Earth reservations, is a federally recognized tribal government that, through unified leadership, promotes and protects the member Bands while providing quality services and technical assistance to the reservation governments and tribal people.

The Leech Lake Reservation Business Committee (RBC)

The Leech Lake RBC is the governing body with their offices in Cass Lake. The RBC consists of a chairman, secretary/treasurer, and three district representatives:

Carri Jones, Tribal Chair

*C*arri Jones was elected Chairwoman of the Leech Lake Band of Ojibwe on June 12, 2012, becoming the first woman and youngest person to ever hold the position of Tribal Chair on the Leech Lake Tribal Council.

Chairwoman Jones is an alumnus of Bemidji State University where she majored in both Accounting and Business Administration with a minor in Financial Fraud Examination. Chairwoman Jones has been accepted into the Healthcare Administrative Master's Program at the College of St. Scholastica and will begin in Fall 2014.

Prior to holding public office Chairwoman Jones established a successful 12 year career in Tribal Government Administration, Finance, and Indian Gaming. She served as the Leech Lake Band of Ojibwe's controller of finance from 2005 – 2008. She also worked as the controller of finance for the Fond Du Lac Band's Black Bear Casino in 2009, ultimately returning to the controller position at Leech Lake in 2010.

Chairwoman Jones brings specific competencies to her role in tribal leadership. The knowledge and experience she has gained through education, and throughout her career, strengthen the capacity for conscious business decisions in both the council chambers, and while fulfilling the day to day responsibilities of her elected position.

Chairwoman Jones also serves as a member of the Minnesota Chippewa Tribe's (MCT) Tribal Executive Committee (TEC). Chairwoman Jones also chairs the Leech Lake Tax and Gaming Commissions, which are units within the tribal government structure, that exercise the Band's sovereign authority within Leech Lake's territorial boundaries.

Other committees include: Minnesota Indian Affairs Council (Member), MCT Legislative Sub Committee (Member), and the Midwest Indian Health-board (Member).

Associated Memberships include: Minnesota Indian Gaming Association (MIGA), National Indian Gaming Association (NIGA), National Congress of American Indians (NCAI), Minnesota American Indian Chamber of Commerce (MAICC) and the Midwest Alliance of Sovereign Tribes (MAST).

Chairwoman Jones has two children, a dog and resides in Cass Lake. 🕸

Penny grew up just outside the village of Inger and has spent a majority of her life living and working on the Leech Lake Reservation. Prior to being elected as Representative, Penny worked as Executive Assistant to the District I Representative for six years where she gained valuable experience and vast knowledge of the internal and external operations of the Band; also working hand in hand with the five Local Indian Councils of District I as well as the at-large LIC's Twin Cities and Duluth. Penny has served as Chairperson of the Winnie Dam LIC which allowed her first hand insight into the needs, wishes, and dreams for their communities and the pride each and every community member holds. This experience was extremely beneficial and only strengthened her belief on how much working together as a team can accomplish. The office

of the District I Representative attends all District I LIC meetings along with all community events and cultural activities.

Before beginning her career in Tribal Government, Penny worked at the Leech Lake Tribal College as a federal work study student providing administrative support, to eventually becoming Dean of Student Services. Penny was employed as Office Manager for the Health Division, then Tribal Health Director for the Leech Lake Band of Ojibwe. She was able to complete her A.A. degree while working at LLTC and later attended Bemidji State University working towards a B.A. in Indian Studies.

Since her election as a member of the Leech Lake Tribal Council, Representative De Vault has been working tirelessly advocating for her District and the Band as a whole, in so many areas. One major highlight: her office has held the groundbreaking and grand opening of the Jackson Village Playground/Recreational Area. The local youth came to the Winnie Dam Local Indian Council meeting and expressed some of the opinions about lack of activities in their community. It was suggested that the children pool their efforts, write a letter and request a remedy to this situation, and the result is the 3 new playgrounds in District I, II and III. Dreams achieved through hard work and commitment from the local youth, LIC, Tribal Council and Planning Division. Representative DeVault also recently became selected to sit on the Minnesota Chippewa Tribe Health & Human Services and Education Sub-Committee. (**)

LeRoy Staples Fairbanks III was elected as the Leech Lake Tribal Council's District III Representative in June 2012. District III, the largest of the Leech Lake Band's three districts, includes the communities of Cass Lake, Onigum, Oak Point, Buck Lake, Mission and Cass River.

LeRoy began his career with the Leech Lake Band more than ten years ago with the Leech Lake Housing Authority, before moving to the Human Services field. He became a certified alcohol and drug counselor (CADC Level II), and joined the management team at the Leech Lake Human Services Halfway House.

In 2008, LeRoy was elected to represent District III on the Leech Lake Housing Authority Board of Commissioners. In 2010, LeRoy accepted an offer to join the Leech Lake Band's senior management team as the Band's Deputy Director. In that capacity, LeRoy served as the assistant chief administrative

officer for the Band's programs and entities. As a Housing Commissioner and Deputy Director, LeRoy developed a deep awareness of the issues and challenges facing Leech Lake. He worked to address these challenges as well as worked to identify opportunities to make life better for all Leech Lake people.

One of LeRoy's passions is volunteering with youth, primarily through sports teams and sporting events. His commitment to continue to be involved in the community has reaped rewards as he has witnessed firsthand youth start to make better choices, gain confidence and increase their sense of belonging within the community after becoming engaged in these positive events.

In the short time since being sworn in as a member of the Tribal Council, LeRoy has made strides in developing and maintaining a transparent system of governance by hosting regular open forums for all District III members, and also publishing expenses. He has also continued his commitment to community by personally investing in the Leech Lake Tribal College's endowment and establishing a new scholarship program. LeRoy has resided on the Reservation for the last nineteen years and currently resides in the Mission area north of Cass Lake. He is married to his wife Becky and they have three children. So

The Adoption Program's main function is to find adoptive homes for our Leech Lake children who are available for adoption via Child Protection. We are not able to assist with private adoptions at this time.

Pre and Post Adoption resources are available for adoptive families. There is little cost to the adoptive family, mainly the cost of filing the adoption petition (which can be waived by the court) and cost of filing for a new birth certificate.

The adoption process will take a minimum of six months to one year. Adoption subsidies are available for those children who are eligible.

Adoptive families must be either licensed or eligible for licensure in Foster Care while awaiting for finalization of the adoption.

Ahnji-Be-Mah-Diz Halfway House

Ahnji Be Mah Diz (Ojibwe language meaning "change your way of life") is a halfway house located on the Leech Lake Reservation, owned and operated by the LLBO. The facility provides a sheltered live-in situation for chemically dependent men who want to live a life free of alcohol or any other mood altering chemical.

Our program objectives are to guide, support, and encourage alcoholic/chemically dependent men, coming from a primary treatment or hospital setting. The main focus is to help them find a comfortable balance physically, mentally, spiritually, and emotionally, so that they can return to the community as a productive person. Objectives are usually accomplished by a client in a period of up to 90 days. The 6 bed facility admits men 18 years and over. Staff is on duty 24 hours a day.

In addition we also provide a sweat lodge that is open to the community, every Tuesday, which starts tentatively at 4:30 p.m. Also we have AA meetings on Tuesdays @ 7:00 p.m., Wednesdays @ 11:00 a.m., and Thursdays @ 7:00 p.m.

The Leech Lake Air Program was established in 2001 with Leech Lake Air Quality Specialist Brandy Toft. Within the Leech Lake Air Program numerous air quality projects have been initiated, completed, or ongoing, including but not inclusive to: diesel retrofitting and emissions reduction, alternative energies - passive solar and a wind feasibility study, radon testing and mitigation, burn barrel ordinance and recycling, indoor air quality assessments, and airsite monitoring for PM 2.5, dioxins, toxins, wet deposition mercury, and meteorological data collection, While being involved with and serving on a number of local, regional, and national organizations regarding air quality, the Leech Lake Air Program has established a number of partnerships with the local communities, schools, and organizations to promote air awareness and improve air quality for the Leech Lake Reservation.

The Leech Lake Air Program works closely with the Green Team to further implement sustainable practices for the Leech Lake Band of Ojibwe.

The Leech Lake Air Program strives to maintain and continue to build capacity, while protecting the health and environment of the Leech Lake Reservation.

Anishinaabe Women's Halfway House

The Leech Lake Anishinaabe Women's Halfway House treatment component is a seven bed facility designed to work with the client as a "whole", Native American 12 step approach. We provide individual counseling, groups, Cognitive Behavioral therapies, Service coordination, relapse education as well as incorporating women's issues, with a special focus on trauma, grief and loss for a total or minimum of 15 hours per week of treatment.

This is the time to silence the world around you and to put the focus back on yourself and your recovery; a chance to build a relationship with yourself and the Creator (higher power of your choosing). To help you to grow and strengthen as an individual in preparation to return back to your home, family, community and share your healing experiences with others.

We are a team and as a team we work together, we are women with a vast array of experience and heart knowledge to reach out to those that are hurting. We have an open door policy; no problem too big, no question too small. We provide nothing but the best possible sober living conditions to promote self worth and self esteem right from the start. Our philosophy is all about community, which is vital to our tribe. At the Leech Lake Anishinaabe Women's Halfway House we have a sense of family and sisterhood.

We have fully trained and licensed staff, 24/7 camera surveillance and security. Our building is new with a playground for visiting children. We encourage clients to have family members come to visit.

Clients are referred to Inpatient Treatment, Outpatient Treatment, Aftercare and Relapse Prevention programs, and Halfway Houses. We collaborate with treatment centers, social workers, probation officers, hospitals and schools to make the best possible plans for clients to obtain and maintain sobriety.

Priority assessments are for pregnant women and adolescents; civil commitments for clients who are very ill due to chemical/alcohol use.

Mission

To promote healing of the spirit, mind, and body and address the root causes of crime and delinquency.

Our Program Model

The Bamenim Anishinaabeg Program Model is a strength-based, client-centered, family-focused model, grounded in Anishinaabeg values and culture, guided by the Four Hills of Life, the Four Seasons of the Year, and the Four Phases of the Wraparound Principles of National Wraparound Initiative, based on data-driven decision making and measurable outcomes.

The Four Hills of Life

The First Hill - the Abinoojiiyensag (Babies) and Ikwezensag Miinawaa Gwiiwizensag (Little Boys and Girls) Stage.

The Second Hill - the Oshkaya'aag (Youth) and Oshkinaweg Miinawaa Oshkiniigikweg (Adolescent Boys and Girls) Stage.

The Third Hill - the Gichi-Aya'aag (Adults) and Ininiwag Miinawaa Ikwewag (Men and Women) Stage.

The Fourth Hill - the Nookomis Miinawaa Mishoomis (Grandmother and Grandfather) Stage.

Four Seasons

Ziigwan (Spring): Participants may partake in springtime activities such as maple sugar harvesting.

Niibin (Summer): Participants may participate in summertime activities such as fishing, berry-picking, and harvesting medicines.

Dagwaagin (fall): Participants may participate in fall activities such as ricing and hunting.

Biboon (Winter): Participants may participate in wintertime activities such as storytelling.

Behavioral Health - Eliminating Health Disparities Initiative (EHDI-MDH)

Behavioral Health integrates behavioral health with primary health care for women and adolescent girls who have experienced or are experiencing trauma, alcohol/drug abuse and/or violence in their lives. The program also assists in suicide prevention. The program will provide assessments, evaluations education, therapy and case management.

Three main objectives of Behavioral Health EHDI-MDH:

- 1. To provide proactive behavioral health assistance to children, youth, and their families living on the trial reservations, urban areas, and in Alaskan Native villages.
- 2. To decrease the risk factors that contribute to youth violence, bullying, and suicide.
- 3. To increase the protective factors that are linked to the healthy and safe development of American Indian/ Alaskan Native children and their families.

Behavioral Health EHDI-MDH provides access to a number of activities for American Indian tribes. Some of those activities are: grief and loss issues, relationships, stress, anxiety, and depression. Historical and generational trauma, living with chronic diseases, domestic violence, communications skills, support for lifestyle changes, bullying, well-briety, suicide, leadership skills, and self-esteem building.

Brownsfields Program

A "Brownfields site" means real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant." CERCLA 101(39)(A) (2002). Brownfields sites typically include former industrial sites. Some examples include former textile mills, teel plants, tanneries, and concrete manufacturing sites. The newest program to the Leech Lake Environmental Department, Brownfields Grant Program which started in 10-03. The Leech Lake Band of Ojibwe received this grant from the Environmental Protection Agency (EPA).

Brownfields sites are abandoned, idled, or under used industrial and commercial properties where expansion or redevelopment is complicated by actual or suspected environmental contamination. By investigating and cleaning up Brownfields sites, many of which are abandoned properties that pose an immediate threat to the local community, development can take place without fear of environmental legal liabilities. This benefits the Leech Lake Band of Ojibwe and surrounding communities by bringing jobs to the area, making abandoned property functional, and possibly preserving sites that might have historical significance to the community.

With certain legal exclusions and additions, the term `Brownfields site' means real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant.

This is accomplished through advocacy, supporting choice, expanding and strengthening the child care delivery system. We promote building community through partnerships, coordination and collaboration. We offer a variety of services to reach our mission to support families and child care providers.

Wraparound Program

Provide funding to assist American Indian families who are working or enrolled in school in paying for their child care costs. Determination of eligibility and amount of copayment is based on family size and income.

County Registration & Background Check Fee Assistance

Assist families with costs for fees for Legal Non Licensed providers in order to access services from the county child care assistance program.

Child Care Providers Services Recruitment

Provide information and technical assistance to those interested in beginning or expanding childcare services.

Licensing

Develop and implement strategies in building the capacity of licensed childcare and improving the quality of childcare by ensuring that licensing standards are being met.

Compliance & Monitoring

Conduct visits to ensure compliance with the Leech Lake Band of Ojibwe licensing standards.

Grants

Funding to build quality child care in child care programs.

Training

Funding to provide staff professional development and comprehensive training opportunities to licensed, nonlicensed providers and families within the service area.

Technical Support

Support & information on child development issues regarding business practices, health & safety, quality care, child development, tax benefits, cost of child care and other issues surrounding child care needs.

Child Protection Program

The goal of the Child Protection Program is to provide services that ensure the safety, permanency and well-being of children. Services offered through the Child Protection Program include Intake, Assessment, Case Management and Family Support.

Eligibility Requirements

- Services are provided to families identified through an incoming child maltreatment incident report on a child who is a member of the Leech Lake Band of Ojibwe.
- Reports initiated within Leech Lake Reservation boundaries are sole responsibility of the Leech Lake Child Welfare Department Child Protection Program.
- Reports throughout the United States outside the Leech Lake Reservation boundaries are the joint responsibility of the county in which the child resides and Leech Lake Child Welfare Department.
- Services outside of the Leech Lake Reservation boundaries may be provided by the Urban Child Welfare Program or the Leech Lake Child Protection Program depending on court jurisdiction.
- Counties outside of the Leech Lake Reservation boundaries are required by the Indian Child Welfare Act to notify tribes when a child protection case has been opened within their county that involves a tribal member.

Intake Procedure

Intake Workers gather information from child maltreatment reports made by community members and mandated reporters to determine if the circumstances should be investigated or if a family is in need of resources to prevent a child from being placed out of the home.

Assessment Procedure

Assessment Workers investigate child maltreatment reports and determine if there is a need to remove the child from the home due to unsafe conditions or if the household needs resources to prevent family disruption.

On-going Case Management Procedure

- Case Managers provide comprehensive services for the best interest of the child. Services may be offered to families who have had children placed out of the home with the ultimate goal of reunifying the family or to connect families with resources that will assist them in providing a safer environment for their children.
- The Family Support staff assists families with transportation to necessary appointments relating to their case plan, completing applications for essential resources, provide supervised visitations and other services that support families in strengthening their family structure.

Community Services Emergency Home Repair Program

This Community Services Program is an emergency home repair program that provides emergency home repairs to Leech Lake Band of Ojibwe enrollees who own their home. Elders, 55 years of age and older and Disabled Leech Lake Band Members shall be the top priority for the program. They shall receive emergency services at no charge.

Our program will accept calls on a first come, first serve basis. If there is a risk to the health & safety of a constituent, the request will be deemed an emergency and addressed as quickly as possible. This program also provides services to other divisions within the Leech Lake Reservation.

Services Provided:

- Electrical Services; No electricity, meter loops, interior wiring, outlets, panel pox, fuses, & breakers.
- Carpentry Services; Door, window, roof, and flooring replacements, installation of handicap ramps, bathrooms and grab bars.
- Plumbing Services; No water, hot water heaters, tank & toilet replacement, broken water lines, plugged toilets, septic system that is plugged out to clean out, pressure tanks and repairs or replacement of sump pumps.
- Heating Services; No heat, troubleshooting, emergency replacement of furnaces. (Must utilize EAP funds first, as we area last resort.)

Conservation Enforcement

The Department of Conservation Enforcement is dedicated to the protection of the water, land, forest, fish, wildlife, plants and other resources present upon the Leech Lake Reservation. Among our many duties, we write fire permits, enforce fish and game laws, regulate logging, wild rice harvesting, and plant resources, and generally protect the Band's many resources for the use of future generations.

The Division of Resource Management is dedicated to the enforcement of the fish and game laws upon the Leech Lake Reservation.

The Leech Lake Conservation Department was establish in 1975 after the 1972 Hunting and Fishing agreement between the State of Minnesota and the Leech Lake Band of Ojibwa. Enforcement is a management tool used to protect all natural resources, so that these same resources will be available for all future generations to enjoy and utilize. Duly constituted and properly identified Leech Lake Conservation Officers and Minnesota Conservation Officers are empowered with the authority to arrest Non-Indians and Tribal members for violations of State and Reservation game and fish laws committed in their presence and can initiate proceedings for these violations in County or Tribal Courts. The Leech Lake Conservation Department presently employs four full time Conservation Officers, stationed within the exterior boundaries of the Leech Lake Reservation.

The Leech Lake Band of Ojibwe is committed to protecting cultural heritage, as it is one of the central features that define human existence. While most people envision archaeology purely as ancient artifacts buried beneath deep layers of earth, archaeology also encompasses historical components. The term cultural resource includes both prehistoric and historic contexts as well as Traditional Cultural Properties. Our department is dedicated to identifying, preserving, protecting, and understanding our collective past.

Heritage Sites

The Heritage Sites Program conducts archaeological research within the Leech Lake Reservation, the Chippewa National Forest, and other areas within Minnesota and the Upper Midwest. We are a profit-based Program, combining cultural resource management (CRM) with a money-generating aim, which benefits both the cultural resources and the LLBO.

Tribal Historic Preservation Office (THPO)

The Tribal Historic Preservation Officer (THPO) is a federally appointed agent who oversees cultural resources within Reservation boundaries and advises federal, state, and county agencies in the management of cultural and historic properties throughout the region. The THPO works with the Tribal Archaeologist to ensure that all cultural properties are protected and preserved under current historic preservation legislation, including federal, state, and tribal regulations and ordinances. Under the National Historic Preservation Act (NHPA) (http://www. achp.gov/nhpa.html), the National Environmental Policy Act (NEPA) (http://www.epa.gov/compliance/nepa/), and other legislation, all governmentally associated ground disturbing activities must be reviewed for cultural resource sensitivity, just as they are reviewed for environmental sensitivity.

- Day Labor Participants must present a valid identification to the cashier to receive pay.



Fish, Wildlife & Plant Resources Program

Fisheries Program

The Fisheries Program within the Division of Resources Management works to protect and enhance the fisheries and other aquatic resources on the Reservation for current and future generations of tribal members. The Leech Lake Reservation has abundant surface waters with about half our surface area covered by lakes, streams or wetlands. There are over 250 named lakes and many miles of boatable streams on the reservation. The most popular large lakes include Leech Lake, Lake Winnibigoshish, and Cass Lake, but there are hundreds of other lakes that contain fish on the Reservation. The Mississippi River also passes through the Reservation. There are over 50 species of fish found on the Reservation with walleye, Northern Pike, Largemouth Bass and Pan fish the most popular for sport fishing. Tribal members also hold the lake Whitefish, a species only found in some of the larger deeper lakes, in high regard.

The Fisheries Section of the Fish, Wildlife, and Plant Resources Program annually undertakes a number of projects to enhance or monitor fish populations in Reservation waters.

Invasive Species Program

The Invasive Species Program (ISP) is charged to:

- 1. Manage and protect terrestrial, forest, and aquatic ecosystems from non-native invasive organisms.
- 2. Conduct environmental reviews.
- 3. Sustain and enhance programmatic growth through grant writing.
- 4. Provide public outreach and education.

We also seek to elevate tribal values regarding traditionally used natural resources among state and federal agencies, as well as the general public.

In addition to field work directed specifically to reduce the spread of invasive species in forest, terrestrial and aquatic systems, we also conduct environmental reviews. The ISP currently assists other DRM programs with the environmental review of all proposed projects within the LL Reservation and Chippewa National Forest boundaries that may affect native plant communities, traditionally used plants, rare and sensitive plant speciesm, and the spread of non-native invasive plants or other organisms. Projects may include those proposed by DRM programs, LLBO programs, Indian Health Service, Chippewa National Forest, and utility companies.

Fish, Wildlife & Plant Resources Program

This program conducts outreach to tribal members, LICs, general public, special resource user groups (traditional netters), and other agencies with the LLR boundary regarding the impacts in non-native invasive species in terrestrial, aquatic, and forest ecosystems. Currently, the Invasive Species Program is running a pilot project to provide community nets for traditional netters for use only on Lake Winnibigoshish in order to prevent the spread of invasive faucet snails.

We assist LLBO programs, tribal members, and private property owners with the LLR plant identification, especially plant invasive species. In conjunction, the ISP consults with the above groups regarding a variety of land management strategies to protect traditional natural resources.

Wildlife Program

The Wildlife Program within the Division of Resources Management works to protect and enhance wildlife populations on the Reservation for current and future generations of tribal members. The Leech Lake Reservation is located near the junction of three major biomes (habitat types), including the boreal forest, northern hardwoods forest, and the tall grass prairie. This results in us having a very high diversity of wildlife species. There are approximately 58 species of mammals that occur on the reservation, 243 species of birds, 27 species of reptiles and amphibians, along with untotaled numbers of invertebrates like insects.

The wildlife program has undertaken, and participated in, many habitat enhancement programs over the years. These activities are frequently used as a means of providing or improving habitats that are in short supply due to human impacts to the environment.

Plant Program

The Plant Resources Program conducts surveys to identify quality habitat for plants and animals on the Leech Lake Reservation. We also map the locations of invasive species. We then work to protect, enhance, or restore these sites so that they may support traditionally important plants as well as rare and threatened species.

The Plant Resources Program recently completed a survey of 5135 acres of high-quality forests on tribal lands of the Leech Lake Reservation. For this project, high quality was defined as relatively undisturbed for fifty years or longer. The baseline ecological data that we collected will be used to assist LLBO in making decisions about land use and land management.

Food Distribution Program

Leech Lake Food Distribution Program provides a healthy food packages to eligible households on a monthly basis. Our service areas are for low-income households that reside on or near Reservation boundaries, households that live off the Reservation have to provide a Tribal ID that shows they are enrolled in a federally recognized tribe. Households cannot participate in the Food Distribution Program and the Snap Program in one given month.

Over the years we have worked on providing a healthy food packages for our households. The Food Distribution Program provides fresh frozen meats, ground beef, beef roast, whole chickens, chicken breast and turkey breast. We also give out fresh produce some are seasonal, red and green grapes, cherries, pears, peaches, apples, oranges, fresh vegetables green pepper, onions, red and russet potatoes, cabbage, cucumbers, celery, tomatoes and mini carrots.

The produce is ordered fresh every week. Our food trucks come in every month. We also have a Nutrition Education Assistant (NEA) for your questions on nutrition. NEA provides handouts on nutrition, recipes and taste testing of foods that are given out in food packages. She will also have cooking classes for interested people.

We also have delivery service to Elderly Band members 55+ and the handicap.

Forestry Department

The Leech Lake Forestry Program is responsible for the management of forests of the Leech Lake Reservation. The work we do on the forest ranges from site preparation for planting tree seedlings all the way to timber harvest. Tree planting, deer repellent applications, and brushing around seedlings are all projects we employ Tribal members through the Temporary Employment Program. We work with the Leech Lake Wildland Fire Program on fuels management projects, mostly in fire-dependent pine forests. We work with other agencies (and the DRM Invasive Species Department) to place detection traps to locate where forest pests are located within the Leech Lake Reservation.

Services we can provide to Tribal members: Every spring we have a tree/shrub giveaway, we can recommend firewood gathering locations, we can look at specific areas/trees upon request and offer advice, we can set up timber sales on allotted lands upon request.

Much of our work is done through our program or by contract. Services offered to Tribal Members include:

- We offer a tree/shrub giveaway every May.
- We occasionally offer fire wood.
- We can look at areas upon request and offer advice.
- We can set up timber sales on allotted lands.

We plant brush around, apply deer repellent, prescribed burns, fuels brushing, site preparation, timber harvests, etc.

Foster Care Program

The Foster Care Program provides foster care licensing for Native Families on and near the Leech Lake Reservation. The Foster Care Program seeks extended family members or other Native Families to care for children who need to be placed out of the home until the child can be reunified with their family. These homes are intended to provide a short-term, safe and stable environment for children while their family works to improve the conditions that resulted in the out of home placement.

A license to operate a foster care home must be obtained through the Leech Lake Child Welfare Commission. Following is the criteria to be licensed for foster care:

- The foster care residence must be located on or near the Leech Lake Reservation.
- The applicant, or applicant's spouse, must be an enrolled member of a federally recognized tribe.
- The applicant shall be the primary provider of care in the residence and who shall be legally responsible for the operation of the residence.
- All foster care parents shall be at least twenty-one years old at the time of licensure.
- Applicants and household members must pass a Bureau of Criminal Apprehension (BCA) background check, a Federal Bureau of Investigation (FBI-Adam Walsh) criminal background check, a Social Service Child Maltreatment background check and a substance abuse test.



General Assistance Program (GAP)

The GAP Federal Grant Award was created to assist federally recognized tribes to plan, develop, and establish the capacity to implement programs administered by the United States Environmental Protection Agency (USEPA). Funding is provided for GAP Programs for the purpose of planning, developing, and establishing Tribal Environmental Protection Programs consistent with programs and authorities administered by the USEPA. GAP provides this capacity assistance to the Environmental Lands Department. GAP resources support developing and maintaining core environmental program capacities.

GAP activities are related to establish education, outreach, public participation, compliance assistance, and coordination of programs for tribal environmental staff to work effectively.

The Program has worked with the Leech Lake Solid Waste Department to create the Rezycle concept which promotes recycling efforts, traditional values, and opportunities in the community through education and outreach. This included developing, planning and coordinating the annual Leech Lake Rezycle Day Event.

The Program also assists in developing, planning, and coordinating the annual Leech lake Earth Day Event. The program coordinator and Technician are members of the Leech Lake Green Team, a "green" oversight committee for the Tribal Council.

GAP coordinates with the rest of the Environmental Lands Department staff to administer The Summer Youth Experience Program (established in 2009). This program works directly with Leech Lake enrolled youth ages 13-15, as they work alongside the department staff in a professional capacity, throughout the summer months. They experience real time Environmental Lands Department program administration, job duties, and tribal processes, as well as, government to government relations.

Projects of GAP include the following:

Biodiesel Conversion from Waste Vegetable Oil Pilot Project, Leech Lake Recycling Initiative, Leech Lake Tribal Food Guide, Semi-annual Fish Tissue Sampling for Mercury, Demonstration of Renewal Energy on Government Infrastructure, Demonstration of Rain Water Capture on Government Infrastructure, plans to establish a Leech Lake Tribal Composting Operation (TCO), and developing a Climate Change Adaptation and planning guide.

Green Team

The Leech Lake Green Team is a group of employees and community members that get together to promote our traditional teachings, sustainability and green ideas on the Leech Lake Reservation. Some of the Green Team projects include:

- Food security using our local foods like farmers markets and growing our own fruits and vegetables
- Food Sustainability Project Make sure our community is getting their fresh food needs met and giving them the tools they need like garden education, canning, and similar projects. This project also works with other Leech Lake Band of Ojibwe programs.
- GIS Food Shed Mapping The GIS department will create a map that will show soil sampling outcomes and help determine different soil types in the communities. This will ultimately provide community members with successful gardens.
- Energy Conservation
- Decreasing waste & promote recycling
- Composting Taking all organic material (fruit & vegetable waste, paper, dryer lint, etc.) from your home and turning it into dirt, which can then be used as fertilizer for your lawn, food and flower gardens.
- Promote reusing existing resources
- Created a Styrofoam Ban on the Leech Lake Reservation Styrofoam can last up to 500 years in a landfill, please stop using styrofoam.
- Works to bring educational trainings to the communities
- Works with local schools
- Works with Cass Lake Garden Club
- Educational booths at local events

Johnson O'Malley Program

The Johnson O'Malley (JOM) Program provides financial assistance to eligible students in eight school districts on or near the Leech Lake Reservation. Each district's respective JOM Parent Committee establishes policies and procedures regarding financial assistance for school related activities.

The Johnson O'Malley Act, passed in 1934, although it has been amended various times, its main objective has remained the same: to ensure that Indian Children receive the educational opportunities that might not otherwise be provided. The JOM program was redesigned in 1958 to be a supplementary program to provide special services to meet the unique and specialize educational needs of Indian students attending public and tribal schools.

Indian Education Committees are elected from parents or legal guardians of eligible Indian students. The purpose of the JOM Parent Committee is to bring about the most effective Indian education program possible. To achieve this, the Indian Education Committee shall participate fully in planning, development, implementation, and evaluation of the JOM Program.

All JOM projects are required to submit a yearly education plan. This is the written document that outlines the plan for providing programs to meet the unique and specialized education needs of Indian Students. It identifies:

- the needs of the Indian students;
- the goals and objectives to be accomplished;
- procedures to be followed; and
- methods to be used in evaluating the program.



Land Department

The Leech Lake Land Department is responsible for the administration and management of all Tribal, Band and allotted lands as it relates to surface and subsurface leasing, permitting and rights-of-way, land acquisition and disposal, trust estates planning and implementation of land use ordinances; in order to maximize utilization of Indian lands, generate revenue, assure all land transactions are advantageous to the Indian landowner; promote trust land consolidation activities and trust estate planning.

The Land Department's priority is to increase the Reservation trust land base, through land acquisition by purchase or exchange.

Leases

- Residential: Free use residential leases are available to tribal members, must be enrolled in LL Band to be eligible for lease on Band land. MCT members are eligible for leases on tribal lands.
- Recreational Lakeshore leases are available on established Lakeshore leasing tracts on Cass Lake, Boy Lake and Leech Lake. Currently there are no Vacant Lots, however, information can be requested where the Lessee has improvements for sale. Lakeshore lease rental rates are based on a percentage of the Lakeshore Appraisals provided by the Bureau of Indian Affairs.
- Commercial and Agricultural leases, Sand and Gravel Permits or other Right of Way Easements are available on Indian lands for a lease/Permit fee as established.
- Land Use/Building Permits: Any person leasing Indian lands (Tribal, Band Allotments) or any member of an Indian tribe owning fee lands within the reservation boundaries are required to obtain Permits through this office, for any type of development, construction or any other ground disturbance activities.
- A permit cannot be issued without approval by all DRM Programs (see Project Review Check Sheet).

Allotments

Allotments: Acquisition and Disposal, Leasing and Rights-of-way Services Provided:

- Acquisition and Disposal: Trust to Trust: Individual heirs are eligible to sell, convey or gift deed their trust (allotted) land, to the Leech Lake Band or other owner in the allotment. (Land Consolidation). The trust land owner must request an Application (to sell, gift deed) in writing, providing name (as enrolled), date of birth, Allotment Nos. or names of parents they inherited from.
- Leasing and Rights-of-way: All individual heirs are eligible to lease lands, for residential purposes (25 CFR 162); and any person, company, or government is eligible for rights-of-way and easements, provided 25 CFR 169 is followed, and consents are granted. See "Leases" Section for a sample application. All land use requests whether lease, temporary use permit or right-of-way requests must be approved by all DRM Programs (see Project Review Check Sheet).

Leech Lake Diabetes Clinic

The Leech Lake Diabetes Clinic (LLDC) and Program specializes in the treatment and medical management of people living with diabetes and its co-morbidities, as well educating the Leech Lake community on Diabetes Prevention. Clinical appointments are offered in Cass Lake, Bemidji, Ball Club, Inger and Onigum. Clinic visits can include physical examinations, laboratory tests, diagnoses, medication prescriptions and diabetic foot exams. The medical record process is used in assisting patients achieve the standards of care for diabetes. Referrals are made as needed.

The clinic provides Diabetes Self-Management Education/Training (DSME) and Medical Nutrition Therapy (MNT) for patients, families, and friends. The information is offered in individual and group settings, classes and community events. This includes education on healthy food choices, carbohydrate counting, blood glucose self-monitoring, physical activity, weight loss, medications, insulin use, insulin pump use, smoking cessation, coping, depression, behavior change and support.

The LLDC has achieved accreditation with the American Diabetes Association (ADA), which demonstrates that education is being done according to the National Standards, and all education plans are individualized, using an approved curriculum.

The LL Diabetes Program provides events and education on prevention and awareness for the general community, which includes blood sugar screenings, cooking classes, support groups, talking circles, health fairs, fitness and wellness programs, weight loss challenges and foot care clinics. There are scheduled events with youth to emphasize awareness and prevention of diabetes, and the benefits of healthy eating and physical activity by using the W.O.L.F. (Work Out – Low Fat) curriculum and summer and winter family diabetes prevention camps. Presentations have been made at Women's Services, Half-way Houses, schools, Boys and Girls Clubs, etc. These events/classes are offered throughout the reservation.



LLDC provides seminars/workshops on Diabetes for the Tribal staff, IHS staff members, community organizations and surrounding areas. We participate in workgroups and practice grant program management, reporting, budget preparation, policy and procedure development and collaborate with many entities.

Leech Lake Financial Services, Inc.

Leech Lake Financial Services, Inc. (LLFS) promotes economic well-being and community development for the Leech Lake Reservation community with financial and developmental products and services.

By Resolution, the LLBO RBC approved the establishment of LLFS as a non-profit corporation created under Title 8 of the LLR Tribal Court Code. A separate entity, indirectly owned by the Band, LLFS has a 7 member board of directors comprised of area bankers, planners, educators, lawyers and accountants. LLFS has its own offices and policies with two full-time employees.

LLFS operates on a federal Technical Assistance grant from the U. S. Treasury. The goal of the grant is to have LLFS certified as a Community Development Financial Institution (CDFI). The grant provides funding for all but operating expenses, like rent, phone and accounting. The Band fills in the gaps where the grant dollars may not be applied.

Our Products

Whether you are starting a business or starting a favorable credit history, LLFS has products designed for members of the Leech Lake Reservation community.

Small Business Loans - From \$5,000 to \$50,000 and above, LLFS uses a USDA revolving loan fund to provide capital to business on the LLR and within 25 miles of the reservation boundaries.

Credit Builder Loans - Low interest loans up to \$1,000 are available for any employee who can collateralize enough leave hours to cover the amount of the loan, and owes no debts to the Band.

Our Training

Communities with strong financial awareness in the citizenship are healthier, more vibrant, and have less crime. Communities that provide education and access to capital for citizens realize more meaningful employment and a higher quality of life.

Business 101 - A class designed for entrepreneurs, Business 101 provides the "how to" bring an idea to a fruition as a business, and all the steps in between. The class is a requirement for participants in the Small Business Loan Program.

Building Native Communities - With curriculum from First Nations Development Institution and Oweesta, the LLFS are certified trainers for providing financial skills specifically tailored to the LLBO community. This is the education component to the Credit Builder Loan Program.

Credit Building on the Rez - Taught by GP Anderson, a senior certified credit professional, over 120 community members have been trained in credit building, repair and establishment in 2013.





Our Mission

The mission of the Leech Lake Band of Ojibwe Housing Authority is to develop affordable homes and housing opportunities for all Native American families on the Leech Lake Reservation, to provide efficient/sensitive services that lead to self-sufficient tenant/home owners and healthy safe communities.

History

The Leech Lake Housing Authority was formed by the Leech Lake Reservation Business Committee on September 1, 1963 (Ordinance 63-01) and has been in existence for over 50 years to date.

The reformation of a Housing Authority and in independent Board of Commissioners, consisting of six (6) Band Members is a requirement to enter into funding contracts through the U.S. Department of Housing and Urban Development.

Governing Body

The Leech Lake Housing Authority is governed by a Board of Commissioners comprised of 6 Band Members, two members are elected from each district to represent the constituents residing in that district. The Board develops policy for the administration to utilize in the day-to-day operations of the Housing Authority. Currently the Board meets two times a month to conduct business.

Programs

Low Income Rental Program

A RENTAL program for lower income families, follows U. S. Median Income Guidelines.

Mutual Help Home buyers Program

The Mutual Help Program gives low income persons the opportunity to achieve home ownership of a home through the Department of Housing and Urban Development. The Mutual Help Home buyer's program is administered by the Leech Lake Band of Ojibwe Housing Authority.

Leech Lake Housing Authority

Low Income Housing Tax Credit Program

The LIHTC Program is an indirect Federal subsidy used to finance the development of affordable rental housing for low-income households. The LIHTC Program, which is based on Section 42 of the Internal Revenue Code, was enacted by Congress in 1986 to provide the private market with an incentive to invest in affordable rental housing. Federal housing tax credits are awarded to developers of qualified projects. Developers then sell these credits to investors to raise capital (or equity) for their projects, which reduces the debt that the developer would otherwise have to borrow. Because the debt is lower, a tax credit property can in turn offer lower, more affordable rents.

Resident Services Program

The Resident Services Program provides many services to our residents. "We are here to help you." Our program has specific goals and objectives to meet the needs of the residents, while complying with regulations that govern the Leech Lake Band of Ojibwe Housing Authority.

Homeless Program

It is the mission of the Leech Lake Homeless Program to empower people who are homeless in and around the Leech Lake Reservation, by assisting them to find and maintain permanent housing. To educate the broader community about the causes of homelessness and helping to find solutions through community efforts.

Supportive Services for Rural Homeless Youth (SSRHY)

It is the mission of the SSRHY Project to provide confidential, non-judgmental services to homeless, runaway and at-risk youth on the Leech Lake Reservation.

Application Process

Applications are accepted at the Housing Authority office or by mail, email or fax. Upon receiving a complete application the application will be placed on a waiting list for an applicants choice of area. Applicants receive notice of their eligibility.

Leech Lake Underground Storage Tank Compliance Program

The Leech Lake Underground Storage Take (UST) Program offers compliance assistance and inspections to facilities that are federally regulated by the Environmental Protection Agency (EPA). As of 2014, there are 13 gas stations and 7 resorts that meet the requirements to be federally regulated within the Leech Lake Reservation boundaries. The UST Compliance Coordinator meets with each facility owner once a year with a follow-up visit within six months. The goal of these visits is to work with the owners/operators on compliance with guidelines/checklist developed by US EPA to ensure compliance, the UST Compliance Coordinator assists in these inspections. The overall goal of the Leech Lake Compliance Coordinator is to receive Tribal UST Inspector Credentials. After credentials are received, the Leech Lake UST Program will conduct inspections on the Leech Lake Reservation on behalf of the US EPA, while reporting to EPA.

Legal Department

Empowered to oversee the Tribe's legal affairs, provides legal analysis, legal representation, and represents the tribe's legal positions. Works most directly with Tribal Executive, Council and indirectly with Administration.

The Legal Department's mission is to provide legal representation, support and advice in connection with tribal government administration, program development and tribal business for Leech Lake Band of Ojibwe.

The LLBO Legal Department does not represent individuals or handle criminal cases. Also, the information presented here does not promise services or representation. This is for informational use only.

The MIS Administration is charged with the organization and execution of the telecommunications and informational infrastructure of the LLBO.

The Telecommunications Department is charged with providing and maintaining telephone communications to over 2000 desktops and modems.

The Network Department is charged with the installation and maintenance of the LLOjibwe computer network and 300 plus desktop PC's and peripherals.

Eligible participants are all of the LLBO employees and Departments including: Gaming, Tribal College and HUD.

We also repair computers for Leech Lake Enrolled Elders at no fee when necessary.

Manidoo Ningadoodem (Family Spirit) Program

The Manidoo Ningadoodem (Family Spirit) Program is currently the largest, most rigorous, and only evidencebased home-visiting program designed specifically for Native American families. Over 1,000 Native families have received Family Spirit services since its inception. The program is designed to be delivered by Native American paraprofessionals as a core strategy to support young, Native parents from pregnancy to 3 years postpartum. It is an honor and privilege to provide tis comprehensive program to interested families.

Program Objectives

- Increase parenting knowledge and skills
- Address maternal psychosocial risks that could interfere with positive child rearing
- Promote optimal physical, cognitive, social/emotional development for children ages 0-3
- Prepare children for early school success
- Ensure children get recommended well-child visits and health care
- Link families to community services that address specific needs
- Promote parents' and children's life skills and behavioral outcomes across the lifespan

How often do we meet?

Our Health Educators will do home visits with you weekly, monthly, or whatever your schedule allows. You can follow the specially designed curriculum of 63 lessons or choose just the lessons you want to learn about. You will be offered visits from early pregnancy until your child's third birthday.

Medical Transportation Program

Medical Transportation Program (MTP)

This program is offered through the CHR program of the Health Division. CHR employees provide transportation for you in Tribal Vehicles to your medical appointment. Eligibility for this program are Leech Lake Band members, Band members from other reservations, and non-band members. May or may not be enrolled in a MN Health Care Program.

Priority List: 1. Elders; 2. Diabetics/Dialysis; 3. Chemo/Cancer Patients; 4. Heart Patients; 5. Disabilities; & 6. Remaining Population.

Medical Transportation Reimbursement Program (MRP)

This program will pay for the most cost effective way to get you to the closest provider with the level of care you need. Patient must be enrolled in a MN Health Care Program.

This reimbursement will pay for you to drive your own vehicle, have a family member take you or a friend. Eligible reimbursement cost includes mileage at a rate of .20 per mile and parking fees, as well as, lodging and meals if your required medical attention isn't available locally. If you are required to have someone go with you (such as a mother of a child) those expenses are also eligible for reimbursement. This program does not have a priority list.

Medical Volunteer Driver Program (MVP)

This program offers medical transportation by a registered volunteer driver, who will transport you to the closest provider capable of providing the level of care you need. This program pays the volunteer driver directly (Reimbursed at .51 per mile) and the service is provided at no cost to you. If you are required to have someone with you (such as a mother of a child) this program transports you at no cost as well. Patient must be enrolled in a MN Health Care Program. This program does not have a priority list.

Minnesota Tribal Resources for Early Childhood Care

Minnesota Tribal Resources for Early Childhood Care (MnTRECC) provides services throughout the state of Minnesota in cooperation with Child Care Aware and Minnesota Tribal Child Care Programs. Parent Support Outreach Program (PSOP)

Parent Support Outreach Program (PSOP) is being piloted on the Leech Lake Reservation to test the success of early intervention services for families that were reported for child maltreatment and it was determined that Family Preservation services would be beneficial.

This program serves families with children under the age of 11. Eligibility includes referrals from the community and also self-referrals. Participation is voluntary and provides early intervention service that builds upon protective factors that strengthen families. By making resources available, families can be supported in keeping their children safe and out of the formal child protection system, as well as work toward economic stability.

Services PSOP will assist with:

- Case Managers will assist each family in meeting their basic needs in housing, utilities, food, new employment and other case management services.
- If you are not already in a CD program upon entry into the program, you will be asked complete a Rule 25 or documentation of a Rule 25 recently completed.

Recovery Maintenance Program

Recovery Maintenance (formerly Aftercare) provides a curriculum that includes Cultural 'Traditional Tools of Healing' blended in with a continuing review of Relapse Prevention education, and utilizing community resources. This group also focuses on AA/NA (steps 6-12) Philosophies with Native American Principles. The program facilitates a Talking Circle. Weekly/daily inventory of (step 10) monitoring materials and possibly other group assignments may be completed each weeks during client education. Practicing Cultural Spirituality.

We periodically, take monthly trips to attend area Sobriety Feasts and Speaker meetings which are a part of each client's support to their recovery environment. This is encouragement for them to gain support, interact and socialize with recovering people. Other examples of Cultural Teaching to help the client maintain sobriety may be learned through reading material about the "Well-briety and the 7 philosophies, Teaching of the Medicine Wheel and the 12 steps, Anishinaabe - 7 Teachings, etc.

The 2nd half of our group session generally brings in a "Guest Speaker" (Elders, Spiritual Advisors, Cultural Leaders or Educators) to volunteer their time to share their Gifts of Knowledge and Wisdom to the group of Anishinaabe Traditions and Teaching. This helps the client apply these as coping skills / strategies to prevent chemical use.

Requirements of Service

Step down system - Equivalent to approximately 1 year:

- Group A minimum 6 weekly meetings, then step down to;
- Group B for 4 biweekly group sessions, then step down to;
- Group C for a minimum of 2 monthly group sessions, then step down to;
- Group D 2 bimonthly group sessions, then step down to;
- Group E 1 Trimonthly group session.

All to include 1:1 individual therapy including possible service coordination. This program is up to 12 months, pending progress and accomplishing goals in their individualized Recovery Plan.

Relapse Prevention Program

Relapse Prevention provides components of a curriculum that includes an emphasis on the relapse process. Persons will gain knowledge that relapse is not the event of using drugs/ alcohol, but it starts long before using occurs. Early recognition and identification of personal warning signs, symptoms, and other triggers that create the urges and cravings to use - is important for the client to understand recidivism and relapse issues. They will develop insight and build strength to help improve awareness and identify the risk factors to prevent substance abuse. Implementing coping skills and strategies in personal recovery to prevent relapse are few of the basic ingredients towards helping them learn how to prevent use.

This program is intermediate in intensity in between Optx and Recovery Maintenance. This program is comprised of structured 1 day per week, 2 hour sessions, with a curriculum that blends Culture with the abstinent-based model of recovery. The program utilizes group and individual therapy.

Once the client completes Relapse Prevention programming, they may be referred into Recovery Maintenance for our Continuum of CD services.

Rezycle

Through continued support from entire Reservation, Leech Lake Solid Waste staff is committed to caring about waste management for the betterment of the Leech Lake Band of Ojibwe, its members, and the surrounding community.

Safety Department

The Health and Safety Program is responsible for the health and safety concerns of the employees and guests at the Palace Casino and Hotel, Northern Lights and Hotel, White Oak Casino and all other programs of the Leech Lake Reservation.

Reporting Workplace Injuries

Supervisor or Employee will determine:

- The type of transportation needed to a health care facility.
- Will send Physician's Report Form and Leech Lake Band of Ojibwe Employee Return to Work Plan with the employee.
 - Employee's Physician fills out forms and returns them to employee.
 - These forms must be completed and returned to supervisor immediately after treatment. They are also required before the employee can return to work.

In the event of an injury the Employee must notify his/her supervisor within 24 hours to complete the **Employer's Report of Industrial Injury Form**. This form is for our insurance carrier so they have information in the event of a Worker's Compensation Claim.

This form needs to be completed as soon as possible; a recommendation is to immediately fax a copy to Health & Safety Director before sending over the original.

- Send the Original to Health & Safety Director at the Regulatory Board Office
- Keep a copy for department records
- Keep a copy in the employee's Personnel File

Supervisor will start (before the end of your shift) a **Supervisor's Accident Investigation Report**. They will then sit down with the employee and complete the report. Directions to Court

The Courtroom is located on the second floor (East) of the Facilities Center, 16126 John Moose Drive NW, Cass Lake, Minnesota. From the Highway 2 frontage road, go north on John Moose Drive NW (the street to the east of the Leech Lake Reservation Tribal Council Offices and the Dairy Queen) two blocks to the log two-story building.

Case Filing Procedures

There is a \$25.00 filing fee for all new civil actions. If you cannot afford the filing fee, you can request that it be waived by filing a Fee Waiver form.

Court Fines

Fine payments can be made at the Tribal Court Administration Office, or at the Leech Lake Accounting Office (located in the upper level of the Facilities Center, 16126 John Moose Drive NW, Cass Lake). Checks and money orders should be made payable to "Leech Lake Tribal Court." The court also has community service options. Please contact the court for more information.

Attorney Admission Procedures

Attorneys may appear on behalf of any party in any proceeding before the court, provided they are licensed to practice. A license to practice may be issued by the Tribal Court upon filing with the Court Administrator an affidavit attesting that the applicant is licensed to practice law before the highest court of any state. A photocopy of said license shall be submitted with the affidavit. The Applicant must also file an Affidavit that he/she is familiar with the Constitution of the Minnesota Chippewa Tribe, by-laws of the Minnesota Chippewa Tribe and the Leech Lake Band, the Tribal Codes and Ordinances, Title 25 of the United States Code and Title 25 of the Code of Federal Regulations. There is a \$100 application fee for admission to practice before the Leech Lake Tribal Court.

Tribal Employment & Training Programs

The Leech Lake Employment & Training Program provides services to all eligible Leech Lake Enrollees who are receiving Minnesota Family Investment Program (MFIP). The Tribal Employment and Training Program can assist with limited supportive services to help clients maintain their jobs, do job search, GED/High School and training.

Diversionary Work Program (DWP) is a four (4) month intense job search program, it is expected to divert families from having to apply for MFIP.

Family Stabilization Services Program (FSS)

FSS is for current or post - 60 months participants who meet the eligibility criteria. Requires documentation by a qualified professional.

Minnesota Family Investment Program (MFIP) Native Employment Work (NEW) Program

MFIP/DWP clients are encouraged and expected to work. Job skills/Job Club classes are available on a weekly basis.

Tribal Employment Rights Ordinance (T.E.R.O.)

The primary purpose of the TERO program is to enforce tribally enacted Indian Preference law to insure that Indian/Alaska Native people gain their rightful share to employment, training, contracting, subcontracting, and business opportunities on and near reservations and native villages.

A tribe's authority to enact and enforce an Indian/Native employment preference law is grounded in its inherent sovereign powers of self-government. This legal doctrine is the most basic principle of Indian Laws and is supported by a host of Supreme Court decisions. These decisions have held that, "Inherent sovereign powers derive from the principle that certain powers do not necessarily come from delegated powers granted by express acts of Congress, but are inherent powers of a limited sovereign which have never been extinguished." Tribes have a basic relationship with the federal government as sovereign powers. This is recognized in both treaties and Federal statutes. The sovereignty of tribes has been limited from time to time by treaties and Federal legislation; however, what have not been expressly limited remains within tribal sovereignty.

Our Investigators specialize in a variety of Investigations. Our Domestic Violence investigator focuses primarily on the education and prevention of domestic violence. Our Criminal Investigator focuses primarily on prevention of crime on the reservation and prosecution of those who commit crimes within the Reservation. We also have Investigators who focus on the drugs, gangs, and firearm crimes within the reservation. They work in conjunction with several federal agencies and the Minnesota BCA.

Meth Coordinator

Our Meth Coordinator goes into the communities and schools across our Leech Lake Reservation and educate people young and old about the dangers of methamphetamine and other drugs. They set up informational booths and presentations containing information about Methamphetamines and other drug prevention and awareness materials.

Patrol

Our Patrol Division Consist of 15 Patrol Officers and 4 Patrol Sergeants. Truancy Prevention and Intervention Services

This program is responsible for providing services that help prevent students from being introduced to the court system because of unexcused school absences. Contact is made with the parent or guardian at which time school policies are reviewed and options are discussed that will help promote school attendance.

Referrals will occur when a student has seven or more days of unexcused absences at school or unexcused absences for one or more class periods on seven school days. At this time, the school or county sends a report stating that the child is considered "at risk". They are urged to make the referrals as soon as possible so that an intervention does not have to be initiated.

Referrals are made to the Child Protection Intake Worker who first verifies if the child is eligible for services. The Intake Worker then forwards the referral to the appropriate staff for assessment.

Definition of Truant

In Elementary school, a child is considered truant if they miss part of a day for 7 days.

In Middle school and High school, a child is considered truant if they have an unexcused absence for one or more class periods in 7 school days.

Definition of Neglect

Waiver Program

A Long Term Care Consultation (LTCC) is provided at no charge in the home of elders and people with disabilities. Anyone can request this assessment through the Leech Lake Band rather than going through their county social service office. The results are used to determine eligibility for services provided to help people stay in their own homes and in their own communities.

A case manager helps people get the services they need and provides regular follow-up. Examples of services that may be provided are homemaker, chore services, personal care assistance, some home modifications, home-delivered meals, LifeCall emergency response systems, home health aide, and nurse visits.

Waiver and Community Support Grant Information. Please call for full requirements of each waiver.

- Alternative Care (AC): For those 65 or over who are NOT eligible for Medical Assistance (MA); there is a co-pay based on income, assets, and services needed.
- **Community Alternative Care (CAC):** For those under 65, certified as disabled, eligible for MA, and need care at the level provided in a hospital.
- **Community Alternatives for Disabled Individuals (CADI):** For those under age 65, with a certified disability, who are eligible for MA and need services to remain at home.
- **Community Support Grant (CSG):** For those who are eligible for MA are able to direct and purchase their own care and supports or have a family member, have functional limitations that require community support, live in a natural home setting, are eligible to receive home care services from a MA home care agency, and not participating in the Alternative Care Program.
- Developmentally Disabled Waiver (DDW): For those who are eligible for MA based on disability diagnosis, have a developmental disability, meet the ICF/DD level of care criteria, require daily interventions, assessed to need a residential habilitation service, have made an informed choice of waiver services instead of ICF/DD services, and have an assessed need for supports and services over and above those available through the MA state plan.
- Elderly Waiver (EW): For those who are at least 65, eligible for MA, and need services to be able to stay at home.
- Traumatic Brain Injury (TBI): For those under 65 who have a documented diagnosis of traumatic or acquired brain injury, are certified disabled, are eligible for MA, and need care at the level provided in a nursing home or hospital.

Water Resources Program

The Water Resources Program is responsible to ensure that the future of the Band's water resources are preserved and retain the quality and quantity necessary to continue practicing the inherent traditional, cultural and spiritual ways of life of the people which are also protected by Treaties with the United States Government. Funding for these activities is authorized by Section 106 of the Clean Water Act. The Clean Water Act of 1972 was developed to address growing environmental and public health concerns related to water pollution. The act created mechanisms to regulate discharge of pollutants and to ensure appropriate water quality.

What We Do

Our responsibility includes a host of activities ranging from monitoring actual water quality and quantity through collecting data, to planning and implementation of projects, development and enforcement of regulations to consultation meetings with other natural resource management agencies to assure the Band's needs are considered and incorporated when activities are proposed within the exterior boundaries of the Leech Lake Indian Reservation.

Main Tasks

- Review and comment on permit applications pertaining to land use plan permits and proposed activities regarding wetlands and shoreland to minimize potential impacts to aquatic resources from proposed projects.
- Environment outreach and education.
- Water quality planning, assessments and studies: land and stream surveys including water quality, fish consumption reports (tissue samples for organic contaminants, mercury, dioxins and PCB's, invertebrate bioassessments and other studies all involved with current and continuous projects.
- Individual Septic Treatment systems (ISTS) Reviewing tribally permitted ISTS applications and perform inspections and inventory.
- Wild rice management.
- Source water, surface water, ground water and wetland protection.
- Development of water quality standards, watershed based plans and total maximum daily loads (TMDLs)

We share the responsibility of the Summer Youth Experience (SYE), 1 or 2 LL Tribal College STEM interns for 10 weeks from June - August, we also take on short term college interns from LLTC, BSU & Itasca Community College (ICC).

We enjoy partnerships with the U of M Extension, Minnesota Pollution Control Agency (MPCA), Cass, Beltrami and Itasca counties.



Wetland Program

Wetlands are important to the environment in numerous ways. They aid in erosion prevention by holding the soil in place and purify water by filtering it through the vegetation. Wetland plants also help capture and store CO2 from the atmosphere. Many specialized species of plants, insects, mammals and birds are found only in wetlands.

The formation and role of a wetland is driven by its location in the watershed, the presence of water during significant periods, soil quality and, ultimately, plants and animals. In fact, soils and plants act as "identifiers" for each wetland.

As sediment is deposited along river corridors, opportunistic plants and animals seek out the new habitat and flourish. As these areas mature, the soils change which impact the variety of plant and animal species. Thus new species may colonize. This process is called succession.

At the mouths of rivers (where a river meets the ocean) sediments are often deposited forming alluvial plains. Marsh grasses find these areas desirable. In addition, other plants and many animals are then attracted to these deltas.

Other wetlands are formed by aging lakes that fill-in with sediments. This area supports shrubs and trees adaptable to life in a wet environment.

Sustainable Wetlands depend on:

- Understanding how the parts integrate into the whole system.
- Treating the root of existing problems not just manifestations.

- Understanding nature's boundaries.
- Learning to live in balance with natural systems.

Wildland Fire Program

The purpose of the Leech Lake Wildland Fire Program is to provide services in wildland fire suppression, hazardous fuels reductions in the urban interface, and prescribed fire.

The Leech Lake Fire Program has equipment for supporting and suppressing wildfires. Total Reservation acres within the exterior boundaries are about 865,000. Large fires at Leech Lake occur primarily in the grassy meadows along the rivers and lakes. The U.S. Forest Service has protection responsibility on Reservation lands contracted through the Bureau of Indian Affairs.

The Leech Lake Wildland Fire program offers fire suppression support to the Bureau of Indian Affairs, The United States Forest Service, The Minnesota Department of Natural Resources. While working with the Minnesota Interagency Fire Center for fire support across the United States. Working on Helitack Support, Engine Crews, Hand Crews, Communications, and Supply Units. The main wildfire occurrence is a result of human causes in and/ or around the towns of Cass Lake, Ball Club, and Onigum. With a large amount of dry grass and brush around the houses, the wildland urban interface has created an extremely dangerous and complex situation.

Eligibility

- Leech Lake Band of Ojibwe Band Member.
- Native American youth age 14-21 who:
 - Are in a Tribal approved out-of home placement and likely to remain in placement until age 18 or older.
 - Developmentally disabled youth capable of living independently in the community after aging out of tribal approve out-of-home placement.
 - Leave an out-of-home placement after age 16 for adoption, kinship care, or legal guardianship.
- Young adults age 18-21 who have aged out of a tribal approved out-of-home placement.
