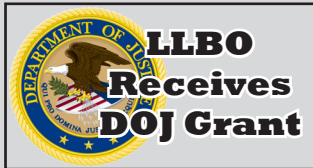

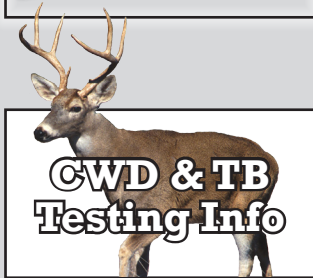

Leech Lake Band of Ojibwe Chairman's Report Qtrly Meeting October 08, 2010

Bena, MN- Good morning everyone and welcome to the quarterly meeting. I want to thank the Council for being very politically active at the federal, state, county, and local levels. We also continue to consult and improve working relationships with Red Lake, White Earth, and the other reservations as well as the surrounding counties on Federal, State, regional legislative and economic issues.

Some of the issues include, the St. Regis Superfund Site clean-up, the Nelson Act Settlement. On the Nelson Act issue we are still in discussions. The last TEC proposal was to do a 1/6 split that Leech Lake continues to oppose. There are also still questions with regard to land claims including our 2415 claims that might be effected by accepting any settlement. We have pushed for a new IHS Hospital and moved that need to the top of the list for Indian Health Care Delivery Demonstration Projects.

Secretary Treasurer Michael Bongo's Report to the People of the Leech Lake Reservation



Greetings Fellow
Band Members:

I have many items and issues to report on, but first I would like to begin by apologizing for not communicating to you all sooner. Since the election I am sorry to say I have been playing catch up as the Tribal Council was in limbo from June 8, through July 9th because of the election protest by the losing candidates. After officially taking office for the beginning of my second term we needed to immediately focus on getting the 2010/2011 operating budget in place. As I'm sure you can understand this is a lengthy process that involves every department and program within the Leech Lake Reservation and is no small or easy task.

I have both good and bad news to report to you the good people of Leech Lake. Unfortunately the distractions never seem to end. As I'm sure many of you have heard the losing Secretary Treasurer candidate and the losing District II candidate from the June 8th elections, along with the Chairman's new assistant, have filed a complaint with the FBI alleging vote buying during the past general election. It has been reported to me that two FBI agents have been going around the reservation questioning

Leech Lake among recipients of Justice Department Grants

Washington D.C.- U.S. Sen. Al Franken (D-Minn.) and Rep. Collin Peterson (D-Minn.) recently announced \$8,125,644 in federal funding will be going to seven tribes in Minnesota to help them strengthen their law enforcement and justice systems.

The funds will be administered by the Department of Justice through the Coordinated Tribal Assistance Solicitation .

The CTAS grants will be awarded through the Bureau of Justice Assistance, the Office of Community Oriented Policing Services, the Office on Violence Against Women, and the Office of Juvenile Justice and Delinquency Prevention. All federally recognized tribes were eligible to apply.

Franken is a member of the Senate's Committee on Indian Affairs.

"For too long, law enforcement on Minnesota's reservations has been underfunded and overburdened," Franken said in a news release. "These funds are a good step toward making reservations safer for American Indians across Minnesota. I'm happy to see the Justice Department taking action."

The distribution of funding in MN includes:

- Leech Lake Band of Ojibwe: COPS - Tribal Resource Grant program \$991,275; OJJDP - Prevent and Control Delinquency and Improve the Juvenile Justice System \$368,049; Tribal Governments Program \$399,957.
- White Earth Reservation Tribal Council, develop and enhance the Operation of Tribal Justice Systems \$478,009, Tribal Resource Grant Program \$990,880, Tribal Governments Program \$824,632.
- Mille Lacs Band of Ojibwe Indians: BJA - plan, renovate, or construct correctional and/or correctional alternative facilities \$150,000; COPS - Tribal Resource Grant program \$569,706; Tribal Governments Program \$754,330.
- Red Lake Band of Chippewa Indians, Tribal Sexual Assault Services Program \$300,000;

Other funds included the Prairie Island Indian Community, COPS - Tribal Resource Grant Program \$190,119; Upper Sioux Indian Community, COPS - Tribal Resource Grant Program \$329,600

Federal Government News

Washington D.C.- President Obama's Fiscal Year 2011 budget request proposes \$18.482 billion, a 5% increase over the Fiscal Year 2010 budget, in total funding for Native American programs.

As part of the President's commitment to open Government, and greater engagement with tribal leaders, the White House Office of Public Engagement and Domestic Policy Council hosted a series of outreach calls with tribal leaders during which representatives from federal agencies provided details about the FY 2011 budget request and responded to questions. Each agency organized similar outreach activities and provided material to the public. Throughout these outreach efforts, tribal leaders requested a single document that showed the FY 2011 budget request for Native Americans.

The Administration is committed to strengthening and building on the nation-to-nation relationship between the United States and tribal governments, which is why we are pleased to provide a single document of the President's Fiscal Year 2011 budget request for Native American programs posted on the Department of Interior's website.

Healthy Children Awareness Month

September 2010 was the first annual Childhood Obesity Awareness Month started by First Lady Michelle Obama. In honor of this first, the Leech Lake Health Division Nutrition Program kicked off our “Healthy Children Awareness Month” in September.

The message we are getting out is this: Let us all help our kids prevent diabetes and other diseases related to being too heavy, such as cancer, heart disease, asthma, and high blood pressure. If a child is in the 85th percentile for his or her age, they are considered overweight. If a child is in the 95th percentile for his or her age they are considered obese.

Start intervening! Stop and become aware now that it is important to help our children become more physically active and eat healthier to avoid getting too heavy. The answers are fun and easy! All that is needed is the will to get moving and learn to eat healthy. DO increase physical activity as a family. DO breastfeed as long as possible. DO work to increase physical activity at school.

5 Simple Steps to Success for Parents

1. Physical Activity
2. Healthy Snacks
3. Plan Healthy Menus
4. Cut Down on Screen Time
5. Organize a School Health Team

We will continue with this campaign through October. The SNAP-Ed Nutrition Education Assistants are providing parent SNAP-Ed participants with a child's portion plate and nutrition education on portion sizes of food for children.

Also, the Tribal Nutrition Program and the Indian Health Service Diabetes Program are working together to bring “The Way of the Circle”. This is a series of workshops for healthier eating and physical activity honoring the traditions of the Native Circle, and cultural pride and the desire for healthier Elders, adults, and children. various individuals and recently have subpoenaed the election records and ballots. While our election process is completely transparent and I myself have nothing to hide, I find it disturbing that not once have I been approached and asked for any information regarding this matter. There's an old saying “if it walks and talks like a duck, swims and flies like a duck, then it must be a duck,” my point is that this investigation seems fairly one sided and directed at the three winning candidates. Again these are needless distractions that get in the way of moving the Leech Lake Reservation forward and keep us from making positive progress.

In my campaign I promised to move Leech Lake forward including efforts to: build a new hospital, a new Bug-O-Nay-Ge-Shig high school, and a new government center. I am pleased to report that I along with our District II Representative have been aggressively perusing those initiatives for our people. Since mid-July I've been to Washington D.C. twice in pursuit of our lobbying efforts on these issues. Most recently Ms. Lindsey White, Bug-O-Nay-Gee-Shig Senior and I testified before the Senate Committee Field Hearing panel on Indian Affairs in White Earth. To my knowledge this is the first time such a Field Hearing has ever been held in Minnesota. I am pleased to report that with the tireless help of the Minnesota Congressional Delegation we continue to make progress toward these goals. However, I would like to remind the people that this is a lengthy process, and as the old saying goes “the squeaky wheel gets the most grease.” I will continue to squeak as loud as possible ensuring that the Leech Lake Reservation holds the federal government to their trust responsibilities of healthcare and education for our reservation.

I would also like to commend Ms. Lindsey White on the fine job that she did in delivering her testimony, as she did an excellent job representing the students of the Bug-O-Nay-Gee-Shig School and the students of the Leech Lake Reservation.

On an added positive note over the course of the past year the Leech Lake Reserva-

tion has quietly built an 18.5 million dollar capital reserve fund. With prudent financial management I anticipate this reserve fund growing to approximately 25-28 million dollars over the next nine months to a year. Currently, the 18.5 million is sitting in Western Bank in Cass Lake earning less than one percent interest (see spread sheet that follows this report). Recently, the Council passed a resolution hiring an investment firm to begin the process of investing a portion of this capital to insure that the Leech Lake Reservation receives maximum return on our assets. As I indicated; this money was earning less than one percent in Western Bank. Sadly Western Bank was making money off our money by loaning it out or investing it at anywhere from 6-8% making 5-7% off of our money. From my perspective this was and is gross mismanagement of our capital reserve fund. If anyone is going to make money off of our assets it should be the Leech Lake Reservation.

To maximize the return on investing this money our investment analyst approved a 2.4 million dollar secured agreement that was well secured and collateralized to the Moondance Jam Corporation for a period of five to seven years. This agreement will earn the Leech Lake Reservation interest at a rate of 8% which is 7.2% more than what we were making at Western Bank. The end result is that we stand to earn approximately \$850,000.00 from this agreement as opposed to the less than once percent or the \$19,000.00 we would have earned over the same time period at Western Bank. Recently, I know that there have been a lot of rumors and speculation and myths regarding this agreement. Contrary to the rumors, there has been no personal gain by myself or anyone else regarding this agreement and I do not have 2.4 million dollars buried in my back yard as rumored. Further, this reflects and meets a number of Leech Lake's strategic objectives including: a buy and invest local resolution that was passed approximately a year ago by the Tribal Council. It also solidifies the Leech Lake Reservation's position as a major local and regional economic engine and leader. Additionally, it solidifies a long term busi-

ness relationship with Monndance Jam Inc. as the Leech Lake Reservation and in particular Northern Lights Casino has benefited from both of the Moondance Jam events over the course of the past two decades. From my perspective this was a sound business deal that was a win-win for everyone. It will benefit the Leech Lake Reservation financially, and it was a sound business decision that will improve community relations, and is a well secured and collateralized investment.

However, what is disturbing about this is that some of my colleagues on the council have taken it upon themselves to hire an outside law firm at the cost of \$475.00 an hour to conduct an outside investigation regarding this agreement with no cap on expenses that could be billed to the Band. This cost could have been avoided by simply sitting down and hearing all of the facts from our investment analysis. As an end result this will needlessly cost the Leech Lake Reservation hundreds of thousands of dollars primarily because certain individuals wanted to use this for their own political purpose and gain.

I would also like to report that recently the Tribal Council entered into an agreement regarding the power line initiative. While I understand that this is extremely controversial with our activists, the reality is we cannot live without electricity in this modern day and age. However, before I get into the details I would like to say how personally disappointed I was in the behavior of a very small group of our Band members during a recent public meeting regard-

ing the power line. The disrespectful behavior displayed at this meeting was very concerning to me. This type of behavior should never, ever be tolerated in such a public meeting. Such use of profanity in the presence of small children and in a public meeting was appalling. The first time this occurred the individuals should have been warned. The second time this happened the meeting should have been immediately adjourned. This behavior by a small number of individuals was a total and complete embarrassment to all people of the Leech Lake Reservation.

This agreement while controversial with some individuals was in my opinion in the best interests of all of the Leech Lake Reservation. The fact of the matter is that the current power grid in this region is antiquated and out dated. Without the updated power line we would face potential power outages and blackouts in the future which could prove to be catastrophic from a number of perspectives. Unfortunately, the reality is that we opened a can of worms with respect to electricity many many decades ago and it is a known fact that in this day and age it is unrealistic to

think that we can live without electricity. Let us stop and think for a moment about all of the things that we take for granted that require electricity. For example: emergency life support at the hospital, lights, heat, water, and the very basics. I would encourage us all to stop and look around both on and off the reservation where ever you go what do you see, power lines.

The current power line agreement will use the same corridor as the pipeline. So what we are talking about is the expansion of what already exists. This agreement will pay the Reservation approximately 5.7 million dollars to include: money to buy additional land, money for emergency energy assistance for our elders, an additional tax rebate paid directly to our Band members, additional jobs for our Band members, and the purchase of various goods products and services from the Reservation. If we must have this new power line then let us get the most out of it which is what we have attempted to do. Whether we wanted it or not the fact of the matter was that this power line was coming through the Reservation no matter how much we wanted it or didn't want it.

I would also like to take this opportunity to explain to you that I often times think

that our Band members take for granted the emergency assistance that they receive from time to time from Council members. To better inform our people, each council member receives an annual line item of approximately \$29,000.00 which they may use at their discretion to assist Band members with various financial emergencies and hardships. This includes things such as: gas vouchers, hotel rooms, assistance with utility bills, rental assistance, and other sundry things that help in times of emergency need. In years past these line items have gotten out of hand. To remedy this situation approximately a year ago the Council, by resolution, divided their line items into monthly allocations limiting spending to \$2,416.00 per month, per Council member. Once the Council members reach this amount for the month their respective line items are shut off until the first of the next month. Often times Band members who receive such services think that this assistance is a free service, and it is not! When we assist Band members this is charged directly back to each Council member's line item, which limits our ability to help people for the remainder of that month. I try to point out to Band members not to abuse this service because someday when they really, truly need help it may

not be there because others have abused it.

I would also like to report on my disappointment with the Leech Lake Housing Authority Board and administration regarding the Inger Community Center project. The low bidder on this project was a licensed, reputable Leech Lake contractor. The Housing Board and administration chose to accept a higher bid from a non-Indian Minneapolis based general contractor. What's disheartening is that to date there has been no explanation regarding why the licensed Leech Lake Contractor was not selected. This is in direct contrast to the Reservation's buy local resolution that I alluded to earlier in this report. My question is: what kind of message does this send? Perhaps I could understand if I was provided with an honest legitimate reason for not going with the low bidder but I have not. From my perspective any Leech Lake contractor who can deliver a quality product in a timely manner that is competitively priced should be given a chance to do the work, especially given the fact that a vast majority of the jobs in this case would have went to Leech Lake Band Members.

I find it deeply disturbing that certain Council members have alleged wrong doing on my part with respect to the Moondance agreement without first of all hearing both sides of the story. This is extremely hypocritical in that there have been a number of irregularities with respect to the Shingobee property that we are just now beginning to uncover. From the preliminary information that I have reviewed over \$250,000 was spent on what I can only characterize as a financial dead horse. Furthermore these expenditures were authorized and approved by just one council member. We have an addition that was being built that we now have learned must be demolished due to poor planning and execution because of a lack of knowledge, experience, and what I would characterize as a poorly managed and executed operation. This has lead to the waste and mismanagement of approximately \$250,000 on an addition that now I am told needs to be demolished because it is structurally flawed. Unfortunately we do not seem to be able to learn from our past mistakes and as a result we are doomed to continuing to make the same mistakes

over and over again. As I have continued to state when you keep doing the same things, don't be surprised when you keep getting the same results. This should be a lesson to us in terms of what happens when you appoint people politically and put them in charge of projects that they are not qualified to execute. In short, this is a reoccurring recipe for disaster.

In closing I first want to apologize for not having reported sooner. However, it is becoming more difficult to find the time to ensure that I continue to keep our Band members updated and well informed. I recognize the importance of doing so and in the future I intend to make reporting a top priority.

I also recognize that there are a number of rumors and insinuations and press releases flying around the reservation and publicly with respect to the Moondance Jam Inc. investment. I would ask that our Band members not participate in such behavior even though I understand that people naturally gravitate to such gossip and rumors in the absence of actual facts. This is harmful and destructive behavior that significantly hurts the Leech Lake Reservation and our people in the eyes of the public. This does nothing to help our efforts regarding progressing in a positive and constructive manner. I realize that exercising patience is difficult, but I would like to reassure the people of the Leech Lake Reservation that I would never, ever do anything to violate the trust and responsibility that you the good people of the Leech Lake Reservation have placed upon me. Everything that I do I can assure you is in the best interests of our people and in our Reservation and I am attempting to use all of my skills, talent and abilities to move the Leech Lake Reservation forward in a positive and progressive manner. However, I find it extremely difficult to be a visionary when a handful of others are only concerned with their own personal and political agenda.

She is survived by her son; Chimakwanibowe Stone of Leech Lake, daughters; Muriel

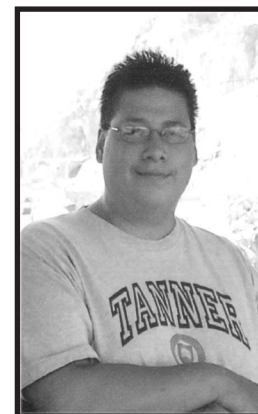

We have also focused on a new high school for Bugonaygeshig and I want to thank Bugonaygeshig Student Lindsey White for testifying on September 11, 2010 before the U.S Senate Indian Affairs Committee Field Hearing on BIA Indian School Construction. Thank you Lindsey for delivering a powerful statement regarding the need for a new high school on behalf of the students and the reservation.

We continue to develop our Reservation Wide Emergency Response Plan. This involves Federal Emergency Management Agency or FEMA training and certification that makes us eligible for federal funding and puts our emergency response teams and law enforcement on equal footing with the state and counties regarding emergency response. This process has entailed a lot of effort on the part of our Tribal Emergency Response Commission so on behalf of the people and the council thank you.

A number of our divisions and staff have been very successful in the area of grants and American Reinvestment & Recovery Act funding. Our Tribal Roads program has captured several million dollars in additional ARRA funding for roads projects all across the reservation. We are working on a number of roads projects with the surrounding counties one of which is the mission road which is one of our most dangerous roads due to the sharp curves and lack of shoulders. This will be a major safety improvement for all who use that road. We also have over 4 million in grant awards to the Tribal Courts, Department of Public Safety, Youth Division, Human Services and Health. I want to take this time to thank them collectively on behalf of the people and the RBC for their hard work.

We have the High Voltage Power line issue. This project is seeking a power line route across the reservation that follows the Enbridge pipeline along highway 2. Most of the council did not feel we had all the information to make an informed decision. The Environmental Impact Statements on the project were not in until recently. These documents are thousands of pages. I have directed our Department


of Resource Management (DRM) to do a summary of those documents so we can get the facts out to the people. Once we know all the facts and potential impacts we can make an informed decision on how to proceed. There was a forced RBC vote of 2-1-1 not to hold a referendum and to accept the offer of 5 million 750 thousand dollars from the power companies. I will not approve that vote by two council members because it was a discussion only item at the meeting and again we did not have enough information to make an informed decision.

At the federal level the Obama administration is making Education and Job Training the key to economic recovery. We are creating an education and workforce development plan for the reservation. We need to be ready now as more federal funding becomes available for these two areas. We have increasing numbers of students in college and vocational technical programs, as well as a record tribal college enrollment. We need a clear focus on education and job training. I am asking the council to make these two areas a priority including allocation of more funds and more focused effort on seeking federal funding to improve our college and vocational technical graduation rates.

We all want Leech Lake to be a progressive tribal government. That requires open and honest government. In regard to this I need to report to the people when we have serious violations of policy or band law. We recently had an unauthorized release of Band funds and the matter is being investigated as a potential misappropriation. Because this matter is under investigation the Council is limited in what we can discuss regarding the matter.

These are just a few things to report. In closing I want to thank all the employees on behalf of the band membership and the RBC for their hard work. Remember to make Leech Lake a leader again we have much more yet to do. I also thank the Leech Lake people for your patience and willingness to discuss issues and concerns that are important to all of us.

NOTICE-DEER DISEASE TESTING

The Leech Lake Reservation DRM in conjunction with USDA APHIS will test tribally harvested deer through December for Bovine Tuberculosis (TB) and Chronic Wasting Disease (CWD)

\$25 Che We Gas Voucher
will be provided per adult deer.
Testing will be limited to 60 deer.

CWD

CWD has not been found in free ranging deer in Minnesota, but has been found in a few domesticated elk and deer from captive herds in Minnesota.

It has not been found in wild deer in Minnesota.

This disease is not known to be spread to humans, but it can be detrimental to wild deer and elk herds.



Bovine TB

TB has been found in deer just northwest of the Red Lake Reservation.

It is believed to have been spread from infected domestic cattle herds.

An extensive eradication program is underway in the infested area to try to eliminate the disease. This disease is caused by bacteria that can be spread to humans from direct contact with infected animals or by consuming undercooked meat

To receive a \$25 Che We Gas Voucher

- Starting **October 4th** you can bring your adult deer to the Leech Lake Division of Resources Management Office in Cass Lake from 8:00am to 4:30pm, Monday-Friday.
- We will not collect samples from fawns. (Fawns are too young to have contracted these diseases and exhibit symptoms), or head-shot deer. Six lymph nodes will be collected from the head of each animal. The chest cavity will also be examined for lesions. Sampling only takes a few minutes on unfrozen animals, so please do not allow the deer to freeze or sampling is more difficult.
- Bring your deer hunting license and tag information. You may not bring in more deer than your legal harvest limit.
- Be able to locate the harvest location from a map that we provide.
- In the event an animal test positive for these diseases the hunter will be notified of test results.

We would like to thank all the hunters who participated in this program in previous years and will appreciate you assistance again this year.

What is Native Vote?

Election Day. Local Native lawyers and students staff the Election Protection component of this campaign.

Why is Native Vote important?

Although Native Vote 2010 is a midterm election, it is VERY important. Eighty-eight percent of the Congress is up for reelection. Indian Country will have an influence on many of these tight races, so tribal communities need to encourage their people to vote! This year, the Congress will be considering legislation that is vital to Indian Country's education systems, energy, natural resources, and many other issues. Actively voting for candidates who are committed to representing Indian Country will bring tribal communities one step closer to fully realizing tribal sovereignty.

What Can You Do?

- Register to vote.
- Registers others to vote. Get voter registration cards from the county and register family members, friends, and eligible tribal community members. There are numerous opportunities at high school events, powwows, and IHS

clinics. We need a strong grassroots effort from all tribes!

- Volunteer to be a Native Vote Coordinator. Every reservation and Native community needs a Native Vote coordinator to get the community mobilized. Talk to your tribal leadership and volunteer to be a Native Vote coordinator.
- Volunteer to be an Election Judge. Volunteer with the county to be an "election judge" on Election Day. Our communities need familiar faces at the polls when we go in to vote.

Voter Registration

In order to maximize the Native vote, it is critical that American Indian and Alaska Native people actively participate in local, state, and national elections. To encourage this effort, the National Congress of American Indians (NCAI) has revitalized an extensive national effort to mobilize the Native vote in collaboration with regional organizations, local tribal governments, urban Indian centers, and non-governmental organizations. Unlike other areas throughout the nation, Indian Country can produce unique challenges and strenuous conditions for voter registration. NCAI has compiled the following suggestions to assist with the challenges of organizing a Get Out the Native Vote effort:

Before you begin registering, make sure you know the procedures, rules, and deadlines for registering voters in your state and country. You can find this information on the Secretary of State website for your respective state. Gather data on voter registration from the county election officer. For example, you can request the number of registered voters by county and precinct to help measure your success. Purchase a complete list of registered voters from the county election office. Pick up stacks of voter registration cards at your county election office.

Register voters and leave voter registration cards at, tribal or local health facilities. The traffic of patients at a local IHS facility is a great place to find people to register to vote. It also gives you time to educate the voter and recruit volunteers as they wait to be seen! Tribal headquarters. All tribal headquarters should have voter registration materials available to the public. Local elementary and high schools. Registering voters at local community schools will give parents and teachers convenient access to voter registration. It also gives you direct access to the next generation of unregistered voters - high school students who are 18 and over. Tribal agencies. Places like local housing, childcare, or economic agencies, are frequented by diverse populations everyday. Canvass. Get-Out-The-Native-Vote (GOTNV) by canvassing your local community and housing areas to register people to vote.

Tribal Colleges. Local colleges and universities offer an opportunity to get young people engaged into the political process at an early age. Post Office. Since local post offices receive the most visits at the beginning of the month, this would be the best time for voter outreach.

Spread the word on the internet, and send people to NativeVote.org. There are so many ways for you to reach people, and the internet is absolutely one of the best ways. Encourage your friends on Facebook and Twitter to send out information about the Native Vote effort.

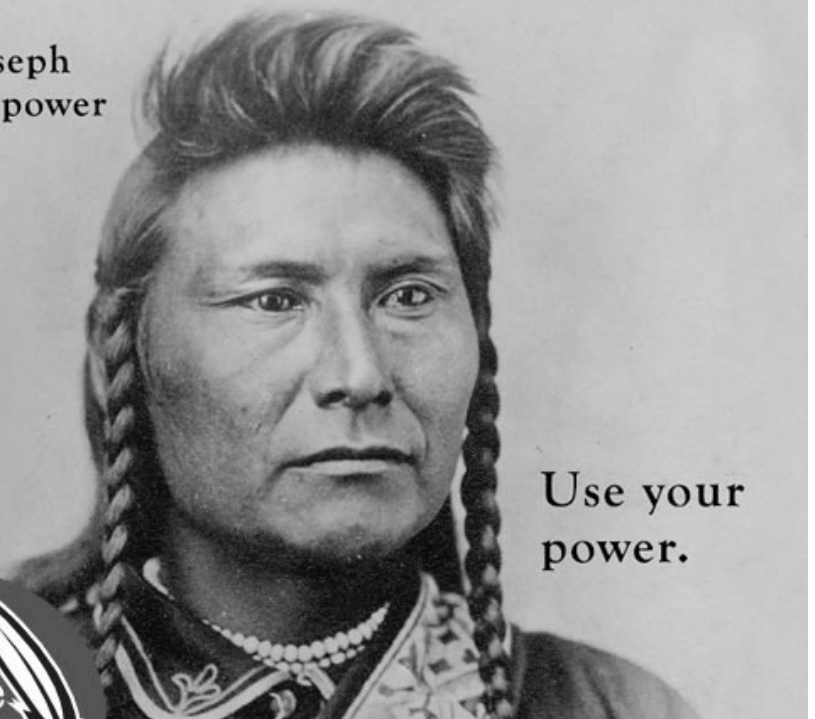
