## Niigaane Ojibwemowin K-6 at Bug-O-Nay-Ge-Shig School Receive Emmy Award

Last fall, the Public Television documentary *First Speakers: Restoring the Ojibwe Language* was awarded a Regional Emmy® Award for Artistic Excellence in the Documentary category! The program features the work of Leech Lake's Niigaane Ojibwemowin language immersion program and other schools in the region working to restore and enhance the Ojibwe language.

Niigaane Ojibwemowin Immersion Kindergarten through sixth grade classrooms participated in the film during late spring of 2010. All academic and social content is taught through the medium of the Ojibwe language at Niigaane. The Leech Lake communities are reclaiming our language as a vital connection to our culture, history, traditions and as a bridge between contemporary society and the traditional way(s).

The Emmy statue traveled to all of the places that participated in the film, the first stop was at the Niigaane School in Bena, where the Niigaane students have been taking care of the award and discussing the importance of our language in today's world. After the Niigaane program, the award traveled to Bemidji State University, the



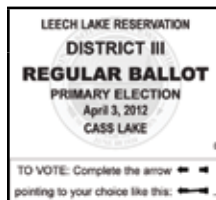
Red Lake Nation, Birchbark Books in Minneapolis, and to the University of Minnesota Twin Cities Department of American Studies to name a few..

This award is a great reminder of the power of language and culture

in our society and how our identity is a direct result of how we communicate. If we lose our language we lose a focal point around which our existence was tailored. Fluent speakers are disappearing as the years pass and if we don't in-

crease the number of speakers we will see other parts of our lives evaporating.

## Secretary Treasurer's Economic Perspective

Greetings, I hope that everyone is having a good winter so far. The last few months have been very busy and very informative. I have been and continue to sift through the Band's finances to find new ways we can use our economy to help create jobs and opportunities for our Band members.

Efforts continue regarding the Powerline negotiations. Last year, our Chairman denied and attempted to renegotiate and improve upon the 5.75 million dollar offer from the power companies by taking them to Federal District Court; however, the Court ruled against Leech Lake as a result. Currently there is an effort to bring these companies back to the table with a new negotiating team. I will keep our Band members informed about this situation as best I can.

We continue to work with Moondance Jam Inc. regarding the 2.4

million dollar loan. Currently we are looking into a number of ways to amicably resolve this issue so that everyone involved comes away from the table with a sense of fairness, but more importantly we are making every attempt to ensure that the Band's interests are fully protected.

The Two-Points property sale died at a public meeting last fall but continues to be an issue that keeps bringing up questions regarding past land deals, putting land into trust and how we manage our natural resources.



I would like to now hand this report over to Carri Jones just as we did at the Bena community center during the quarterly meeting. Carri will expand on our financial reporting

details and give an over-all report on the finances as they are.

Hello Band Members of Leech Lake, The Band is currently under a General Fund Freeze, at the end of January we did a cash flow analysis on the spending that is currently occurring. During that process there were several programs that were over their budgets at the end of January (they should all be at 60% spent). This also leads to having more money going out of the Band than money coming into the Band. We are hoping that implementing this freeze will level off the spending at this time to bring our programs back in line with their budgets. I brought this to the Tribal Council's attention because if it was not addressed immediately we would have had to make major decisions coming into the end of the fiscal year. The majority of the Tribal Council was in favor of freezing the funds to help stabi-

lize the funding for the remainder of the year, this will also help going into the next year with a healthy cash balance. Our divisions that receive grants from the federal, state, and local governments are doing an excellent job staying on track with their budgets. The majority of our funds are from these outside entities. Our divisions are actively seeking out more and more grants to help supplement their programs and expand their services.

Currently the Budget Team is working on the FY2013 budgets for the Band. This is a very lengthy process and major decisions will have to be made. We will be working with the Tribal Council and Divisions for their input during this time to get an understanding of what they are working on and what their needs are for the upcoming fiscal year.

## Cass Lake IHS Dental Clinic Requests Feedback

Be the voice of your community! The dental team at Cass Lake Hospital is soliciting patients / community members to join us for a listening session over lunch on March 20th from 12:00 – 1:00. The dental team would like feedback on what community members and patients feel we do well, areas that they feel we could improve, and ideas on how to implement the improvements. The dental team will

happily answer questions and discuss policies and procedures, but our main purpose is to listen and gain feedback from the people that we serve.

In order to sign up to attend, we are asking patients to call or stop by the dental department and submit their name for the drawing. We will be drawing 5 names and will be notifying the 5 people at the phone #'s provided. We had to limit the number of com-

munity members due to limited space available within our facility to host such an event. We plan to hold these listening sessions quarterly.

Lunch will be provided. This is part of the dental department's participation with the Improving Patient Care (IPC) initiative at Cass Lake Hospital. We have a good understanding of the areas we feel need improvement and areas we feel that we do well, but we

would like to know what patients feel is important in order to meet their expectations and we want patient feedback to better incorporate what is important to patients in our policies and every day practices. ## State Hosts First Indian Education Summit

Last January education leaders from the State of Minnesota and from Native Nations across the state gathered in St. Paul for the first-ever education summit. Recognizing challenges and barriers that American Indian students face was the focus of the summit as well as mapping out possible solutions.

The event was a direct result of Minnesota Education Commissioner Brenda Cassellius having held a listening session last fall on the state of Indian education in Minnesota. Participants identified a need for a continuing dialogue on how to finally develop progressive policies and strategies for Indian students progress. Some would say that this summit is long overdue considering the ridiculous history between State and Federal education officials and the American Indian population. This issue has been simmering within Native Nations in Minnesota and across the country for centuries.

It's difficult to talk about American Indian public education and the sink-holes and pitfalls that seem to swallow our kids up without first mentioning how American Indian people were first introduced to the idea of public education.

The Boarding School Era began with day-schools where Native kids could go to local churches and school-houses to learn during the day and go home at night. This didn't last very long before the powers-that-were realized that assimilation was not happening and the kids were still too connected with their culture, language, and traditions. Once this was realized day-schools gave way to off reservation boarding schools that literally took kids from ages six to sixteen far away from their villages, families and culture so that true assimilation could take hold and a new identity could begin to be formed.

Kids were beaten for speaking their language and for any overt dis-

plays of a connection to their heritage. The situation became so intense that some kids were locked in root cellars for infractions and were deprived of food for further disciplinary problems. Some kids never returned to the homes from which they were taken. Some families still wonder about their relatives, and what really happened at these boarding schools.

These facts have been burned into the memories and minds of American Indian people for a very long time. They are the foundation upon which a vast majority of Indians base their perspective of education in a public setting whether the perspective is conscious and intentional or of a deeper and less cogent manifestation. The underlying psychology that has transpired is that of a lack of trust in education professionals (teachers, counselors, school administration etc.) to the point at which we find ourselves today. Dropout rates are high, graduation rates are some of the lowest in the nation, test scores are tepid, and on, and on, and on.

The listening session last fall and this recent education summit were first steps toward identifying barriers, but the road to resolving some of the deeper issues involved in this equation will take an effort that we have not seen to date. The Education Commissioner and Governor Dayton have started to address the surface of the problem; let's hope efforts continue so that more and more American Indian children can find a proper education so that the greater perspective of progress in Indian Country can take hold on a larger scale.

**Background**

On 01/21/2012 at approximately 12:56 p.m., Leech Lake Tribal Police Officer Vincent Brown was on duty at the Ball Club sub-station when two individuals notified him of a house fire a short distance away. Brown exited the sub-station and could see smoke billowing out from unit #30 on Coral Street and County Road #39. Brown notified dispatch to contact both Itasca County Sheriff's Office and the Deer River Fire Department. As Brown approached the residence he met with the homeowner standing outside and stating there were two people sleeping inside the residence. Brown then entered the smoke filled unit and noticed a kitchen stove and cupboards engulfed in flames. Brown located a male and female sleeping on couches in the living room and struggled to awake them. Brown grabbed the male by his arms and pulled him from the burning unit to a safe distance. The female was finally awoken and Brown escorted her out of the unit to a safe distance. Brown was unsuccessful in extinguishing the fire and decided to check on the other units in the four-plex to make sure no one else was in danger. Brown was able to notify a male in the neighboring unit and escorted him to safety. Brown then found a working extinguisher and was able to terminate the fire. Once the Fire Department and Ambulance arrived, the homeowner was transported to Deer River Hospital for smoke inhalation. No other injuries were reported at this time as the unit suffered moderate damage.

He was preceded in death by his parents and brothers John and Ronald.

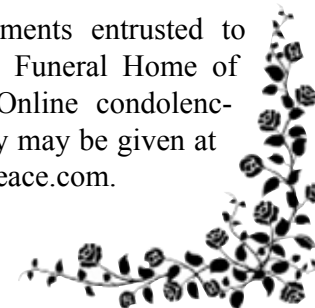

## White Earth Plan Misguided, MIGA Says

A statement issued today by the Minnesota Indian Gaming Association (MIGA) says the White Earth Band of Ojibwe's offer to partner with the State of Minnesota on a casino to benefit the Minnesota Vikings is "misguided," and contrary to long-term tribal interests. Here is the full text of the statement:

The member tribes of the Minnesota Indian Gaming Association (MIGA) continue to oppose efforts by the White Earth Band of Ojibwe to develop an off-reservation casino in the Twin Cities. White Earth has put forth similar proposals at least three times in the past, and MIGA has opposed them on numerous grounds.

First, we believe that any effort by a tribe to expand gambling into off-reservation locations is misguided and contrary to the spirit of the Indian Gaming Regulatory Act (IGRA), which was intended to create jobs and stimulate economic activity on Indian reservations, where traditional approaches to economic development have failed.

Second, White Earth's proposal is contrary to long-term tribal interests because it compromises sovereignty, diverts tribal revenues to non-tribal purposes, in violation of federal law and the tribal government's responsibility to its own members, and sets a dangerous precedent for unwarranted revenue-sharing. By positioning itself as a financing partner offering to develop a casino and share proceeds with the State of Minnesota outside the framework of IGRA, the tribe has waived its sovereign status and put itself on the same level as any private-sector developer.

Third, the premise of the White Earth proposal is that it would address "the extreme disparity in revenues generated by tribal casinos." Since Indian gaming was intended as a tool for economic development on the reservation, it was never envisioned or intended that tribes would benefit equally. IGRA recognized that each tribe would be operating its gaming enterprises on tribal

lands with all the benefits and limitations inherent in those locations. Moreover, the proposal as currently written would not remedy revenue disparities; it would merely increase revenue for one tribe, at the expense of others.

Fourth, the White Earth bill (Article 1, Section 1) asserts a "lack of significant direct revenue to the State of Minnesota" from tribal gaming. In fact, federal law and the rulings of the National Indian Gaming Commission (NIGC) both have reaffirmed that tribes may not divert gaming revenues to states or cities except to pay for benefits or services provided by those entities.

The intent of Indian gaming was to produce revenue for tribes, not states. The suggestion that the state has a right to tribal gaming revenues is simply wrongheaded and totally inconsistent with the stated intent of IGRA. In Minnesota, tribal casinos were developed without a nickel of state assistance. The 41,000 jobs created, directly and indirectly, by Indian gaming have not cost Minnesota taxpayers a dime.

Fifth, the suggestion that the state would bind itself to an exclusivity agreement for thirty years in exchange for 50 percent of the proceeds of a White Earth-owned casino is patently absurd. There is not a single state in the U.S. that, having entered the casino business, has stopped at one casino. What happens when Minnesota decides it needs another casino, and then another?

MIGA member tribes take no pleasure in opposing White Earth on this matter. However, the tribe's proposal is so inimical to the interests of the other tribes in Minnesota that we believe we have no alternative.
