Earlier this fall, the National Center for American Indian Enterprise Development (NCAIED) announced its Native American top 40 under 40. Award recipients were selected based on several aspects of accomplishment and community involvement. The award recognizes 40 burgeoning American Indian leaders across the country that demonstrate direction, creativity, and commitment and made significant contributions in business and in their community.

Leech Lake's Chairwoman, Carri Jones was a recipient of the award as a result of her nomination last summer. Carri is a mother of two, she is the first woman elected as the Chair for the Leech Lake Band of Ojibwe,

# Leech Lake Tribal College Announces David Parnell Speaks to LLBO Youth **Commitment to Expand College Access at White House Event**

eech Lake Tribal College President Dr. Donald Day was with President Obama, ✓ the First Lady, and Vice President Biden along with hundreds of college presidents and other higher education leaders to announce new actions to help more students prepare for and graduate from college.

The White House College Opportunity Day of Action helps to support the President's commitment to partner with colleges and universities, business leaders, and nonprofits, to support students across the country to help our nation reach its goal of leading the world in college attainment.

In 2011, the Minnesota Education Nation Consortium was created between the Leech Lake Band of Ojibwe, the Red Lake Band and the White Earth Band of Ojibwe. The consortium later included Fond du Lac Band of Ojibwe. With each nation maintaining the charter of a designated TCCU (Tribally Controlled College and University) the intent of the Minnesota Tribal College consortium was to work together to make the following educational improvements: the crucial and urgent issue of Ojibwe language preservation, mutually agreed upon grants, partnering and grant endorsements, and mutually beneficial advocacy efforts. The Tribal Colleges will collaborate with each other using practices in the following areas to increase college graduation rates by 20% in 5 years (2020),

- Improve student retention & graduation rates
- Expand transfer opportunities
- Share academic resources & programs
- Increase access through technology infused education
- Impact the economic development of Tribal communities and
- Work to preserve Ojibwe language & culture

"Leech Lake Tribal College is honored to participate in the College Opportunity Day of Action hosted by President Obama and First Lady Michelle Obama. We represent a strong consortium of Tribal Colleges in Minnesota that are committed to increasing access and college opportunities to rural Tribal communities" said Dr. Donald Day, President of Leech Lake Tribal College. "We recognize our mission is to not only provide educational opportunities rooted in Anishinaabe values and culture, but to increase the number of college graduates as a measure of economic growth and workforce impact."

The participants were asked to commit to new action in one of four areas: building networks of colleges around promoting completion, creating K-16 partnerships around college readiness, investing in high school counselors as part of the First Lady's Reach Higher initiative, and increasing the number of college graduates in the fields of science, technology, engineering, and mathematics.

The President will announce new steps on how his Administration is helping to support these actions, including announcing \$10 million to help promote college completion and a \$30 million AmeriCorps program that will improve low-income students' access to college. Today's event is the second College Opportunity Day of Action, and will include a progress report on the commitments made at the first day of action on January 14, 2014.

Expanding opportunity for more students to enroll and succeed in college, especially low-income and underrepresented students, is vital to building a strong economy and a strong middle class. Today, only 9 percent of those born into the lowest family income attain a bachelor's degree by age 25, compared to 54 percent in the top earners. In an effort to expand college access, the Obama Administration has increased Pell scholarships by \$1,000 a year, created the new American Opportunity Tax Credit worth up to \$10,000 over four years of college, limited student loan payments to 10 percent of income, and laid out an ambitious agenda to reduce college costs and promote innovation and competition.

# about the Perils of Meth

avid Parnell is a public speaker, author, consultant, and advocate for drug endangered children. He has literally spoken to tens of thousands of people in over thirty states and in three countries during the past five years about the dangers of methamphetamine. Mr. Parnell spoke to kids at the Bug-O-Nay-Ge-Shig school, Cass Lake Bena, and at the Bena community center.

David spent twenty-three years abusing drugs, seven years of which he was addicted to methamphetamine. Under its influence, he even attempted suicide by shooting himself. He shot himself with an SKS assault rifle. Though he survived, he sustained severe injuries. David came out of the grasp of methamphetamine after a hard and prolonged struggle. As of June 23, 2010, he has 7 years and 4 months clean and sober. Now, he focuses on drug prevention by educating and warning people about the dangers of addictive substances, particularly methamphetamine, in part by using his own life as an example. He has received an overwhelming positive response for his efforts. David presents his lectures in schools, churches, community group gatherings, jails, and rehabs. His audiences include various sections of the society from students

to people recovering from substance abuse. His personal story acts as both caution and inspiration to others. It cautions others to stay away from addictive substances and inspires people to get free from the spell of such substances. It also makes people realize how drug use affects everyone and leads them to get involved in the fight against drugs like methamphetamine.



# **MN Congressional Delegation Bombards OMB Director Shaun Donovan for School Funding**

ongresswoman Betty McCollum, Congressman Tom Cole and Senators Franken and Klobuchar have all been ardent supporters of Leech Lake's efforts to replace the high school building at the Bug-O-Nay-Ge-Shig campus. Congressman Nolan has also paid special attention to and visited the campus as the others have, and all of them have been sending the Director of President Obama's Office of Management and Budget letters that detail the need for increased funding.

The Office of Management and Budget (OMB) is the largest office within the Executive Office of the President of the United States (EOP). The Director of the OMB is a member of the executive office of the president. The main function of the OMB is to assist the President in preparing the budget.

The list of deficiencies include: fungus, heating and air filtration concerns, rodent infestation, electrical problems, sewer backups, mold infestation, lack of alarm systems, and exposed wiring to name just a few.

The Minnesota Representatives mention trust responsibilities that are being ignored and a list of 63 schools that the Bureau of Indian Education fund are similarly in a state of disrepair.

Every election year we hear how much education could be a silver bullet that could help deliver poverty stricken portions of society from such unfortunate circumstances as unemployment, homelessness, high levels of chemical dependency, and a lack of economic opportunity to name just a few. With efforts like ones mentioned above, hopefully Leech Lake will be able to turn the corner in the years to come regarding education.

and she is also a candidate for a Master's Degree program studying healthcare administration, to name just a few of her many responsibilities. Carri is an alumnus of Bemidji State University, where she majored in both Accounting and Business Administration (emphasis in finance) with a minor in Financial Fraud Examination. She also chairs the Leech Lake Tax and Gaming Commissions, which are units within the tribal government structure that exercise the Band's sovereign authority within Leech Lake's territorial boundaries. Her other committee responsibilities include: Minnesota Indian Affairs Council (Member), MCT Legislative Sub Committee (Member), and the Midwest Indian Health-board (Member). The 2014 Native American 40 Under 40 Awards were presented at NCAIED's 39th Annual Indian Progress In Business Awards Gala (INPRO) was held October 8th at the Potawatomi Hotel & Casino.

# **Bug-O-Nay-Ge-Shig School Funding Gets National Attention**

Asy-Ge-Shig School and its state of disrepair, the efforts have garnered national attention. The New York Times released an article in November highlighting the Leech Lake School and paying a special focus to its need for replacement and Secretary of the Interior Jewel's plan to change how funding is distributed to Bureau of Indian Education facilities. The plan is to shift funding to local leaders so that curriculum as well as funding can be controlled by those closest to the learning institutions essentially creating an opportunity for those with the most knowledge of the schools to have the greatest influence over the system instead of having leaders in Washington making decisions from thousands of miles away.

The article goes on to outline the considerably lower reading assessment scores for students that attend BIE schools as opposed to their peers in public schools. Promises of a shift in funding and personal visits from the Secretary of the Interior are a far cry from being able to break ground on a new facility that will indeed help raise test scores, however. National attention, on the other hand, is something that the lobbying

efforts by the Leech Lake Band's leadership had yet to happen. Both the New York Times and the Huffington Post have covered these efforts, and hopefully will result in a change.



# **Bobby Rodriguez Inducted into the Minnesota Boxing Hall of Fame**

Growing up in a family of boxers helped push Bobby Rodriguez to push himself. This local boy from Ball Club, having lived in North Minneapolis for years, had a coupe role models that helped inspire his career as a young boxer reaching the upper levels of competition as a professional.

His Brothers Kenny, Rudy, John and Rafael, that rose in the ranks to fight Sugar Ray Leonard and has been inducted into the MN Boxing Hall of Fame himself, were all professional fighters and provided Bobby the tool necessary to secure his own trajectory that landed him to be inducted into the Minnesota Boxing Hall of Fame in early October, 2014.

Bobby won four championships in Minneapolis and subsequently fought in Los Angeles rising to the rank of 9<sup>th</sup> in the world with a record of 20-0. He has a couple of state titles to add to his accolades as well.

Along with the Leech Lake Tribal Council there were several Senate and Congressional Representatives from Minnesota in attendance as well. Senator Amy Klobuchar said, "we're so proud of this tree. Its fitting that our state is providing this tree. I was there when it was harvested. This was a huge effort. We are letting everyone know about our natural beauty and cultural richness from Minnesota."

Al Franken was invited to speak as well and he said, "It's a big honor to be here. Minnesota children made ten thousand ornaments as we are from the land of ten thousand lakes. One of the ornaments is a dreamcatcher. They are to protect you as you sleep by only letting the positive through while catching the negative."

The good Congressman from Minnesota's 8<sup>th</sup> District Rick Nolan said, "On behalf of the Minnesota delegation, thank you for being here. I want to thank the Forrest Service and Chairwoman Carri Jones and the Leech Lake Band and their help with this tree. What's really wonderful about this tree is that it sits in the middle of this area. There is nothing partisan about this tree. It reminds us all that we are one people, of one nation. It brings us together much like Christmas does."

The next day was busy as the National Museum of the American Indian hosted drum and dance performances by several drum groups and many dancers. Pete White was the event's M.C. explaining the significance of several of the songs and of a few of the dances as well. The Bug-O-Nay-Ge-Shig School Silver Eagles performed as well a Remer's Northland Eagles and the Cass Lake drum.

Chairwoman Carri Jones spoke briefly at the event, "I'm proud to be a part of this event. The whole week will be something that lives in the memories of our students that worked so hard to get here. It will be something we can all look back on with the fondest of memories.

While the National Museum of the American Indian performances were taking place, President Obama hosted the sixth annual Tribal Nations Conference where the President released several new initiatives focused on helping Native youth including: New Native Youth Community Projects, New National Tribal Youth Network program, White House Native Youth Report, Cabinet Native Youth Listening Tour, and the White House Tribal Youth Gathering.

Along with these efforts the President is taking Secretary of the Interior Jewel's order to restructure Bureau of Indian Education school funding seriously. "The Department of the Interior (DOI) is making progress to transform the Bureau of Indian Education (BIE). Since Secretary Jewell's Secretarial Order directing Indian Affairs to restructure the BIE to serve as a support network to schools rather than a direct education provider, DOI, along with ED has made steady progress towards implementing the Administration's vision of high-achieving tribally-controlled schools". There has been national coverage in the New York Times and the Huffington Post regarding the Bureau of Indian Education and the lack of attention that has been paid to these underachieving institutions, including Leech Lake's own Bug-O-Nay-Ge-Shig school, and it is nice to see these efforts having an effect.

"I'm happy to see things like the BIE (Bureau of Indian Education) being discussed at the Congressional level and by Cabinet Secretary Jewell and the President," said District III Rep. LeRoy Staples Fairbanks, "however, the time for talk is coming to a close, and we need to start seeing some action when it comes to our students education as well as the greater trust responsibilities of the Federal Government."

Below are more of the President's priorities that are listed on the White House's "Fact Sheet".

- Supporting the academic achievement of all native American students
- Building stronger Tribal businesses and economies
- Improving Tribal Justice
- Supporting healthy, stron Native American communities
- Pormoting climate resilience and land and natural resources
- Advancing the government to government relationship

When there wasn't an event to go to the students were brought to several different Smithsonian museums as they are all free and there are several of them. They include: African American History Museum, The Culture Museum, The Air and Space Museum, The American History Museum, and the American Indian Museum to name just a few. The Botanical Gardens was the setting for one of the last events where the Northland Eagles Hand Drum performed an honor song for the attendees.




